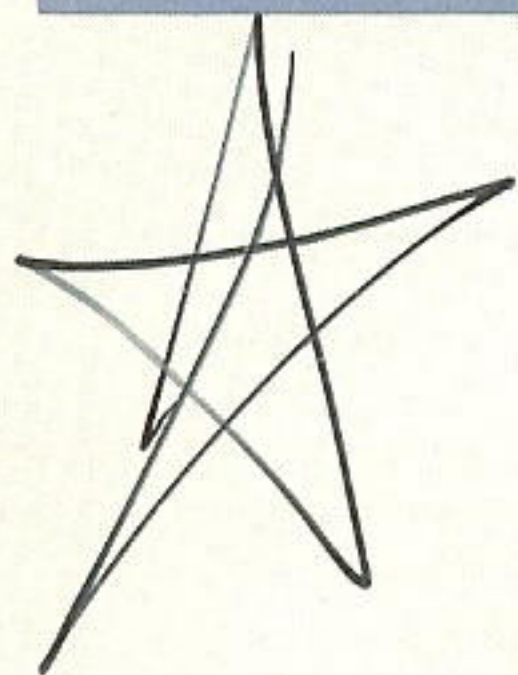

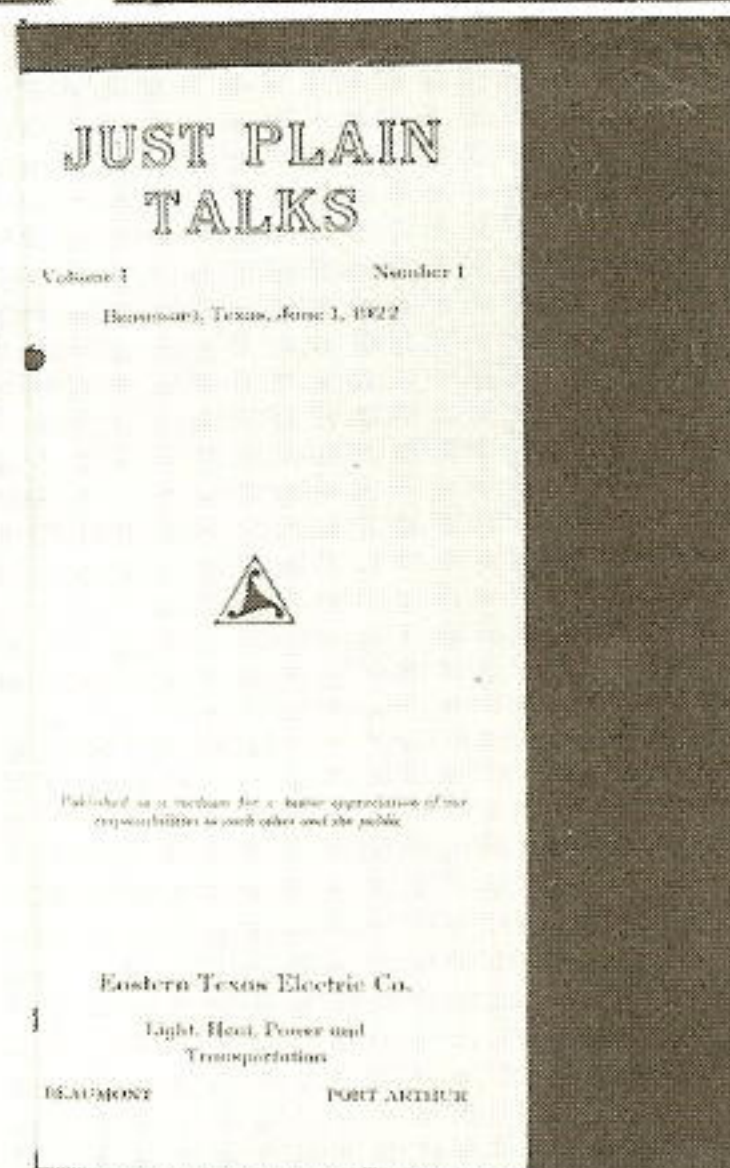

GSU and Entergy agree to combine



On June 8, Gulf States Utilities and Entergy Corporation announced the two companies entered into a definitive agreement providing for the combination of GSU and Entergy. The proposed combination will offer customers in Southeast Texas and Southwest Louisiana lower electric bills, a long-term rate freeze and new initiatives in economic development, the chairmen of the two companies said.

"Combining the two companies is a win-win opportunity for all the key constituents, including customers, employees, shareholders and regulators," said Joseph L. Donnelly, GSU chairman of the board and CEO, and Edwin Lupberger, Entergy chairman and CEO.

Donnelly and Lupberger said the combination of the two companies will create a more competitive and efficient company that will add a new dimension to GSU's well-known emphasis on economic development activities in Southeast Texas and South Louisiana.

Lower energy costs and flat rates for five years or longer are certain to be strong inducements for business to relocate in the GSU area or expand their operations already in place, they said.

Under the terms of the agreement, which was unanimously approved by the boards of directors of both companies, Entergy and GSU will form a new holding company which will acquire all of the common stock of Entergy and GSU. The new holding company, which will be renamed "Entergy," will own all of the stock of GSU and Entergy's operating subsidiaries.

In the combination, GSU common shareholders can elect to receive \$20 in either cash or shares of common stock of the new holding company for each share of GSU common stock. The price will be increased if the transaction has not been consummated by June 5, 1994, to account for the dividends from and after June 5, 1994, that GSU's common shareholders would have received if the transaction had been consummated prior to such date, but not less than 25 cents per share per quarter.

Similarly, the price will be decreased on a dollar-to-dollar basis to reflect any dividends paid by GSU on its common stock during the period from the date of the agreement to the closing. The maximum amount of cash to be paid to GSU common shareholders pursuant to the agreement is \$250 million, and the agreement provides for the proration of cash in the event that GSU shareholders

elect, in the aggregate, to receive more cash than the \$250 million specified. Each of the shares of GSU preferred stock outstanding at closing will survive the closing as outstanding stock of GSU. Each share of Entergy stock will be converted into the right to receive one share of holding company common stock.

Completion of the transaction is subject to, among other things, the approval of the common shareholders of GSU and Entergy and the receipt of required governmental and regulatory approvals. These include approvals from the Louisiana Public Service Commission, the Public Utility Commission of Texas, the Federal Energy Regulatory Commission, the Securities and Exchange Commission and the Nuclear Regulatory Commission. The regulatory process could take at least 12 to 18 months.

How would you like to rocket to the moon and back 10 times? Or maybe you would be interested in traveling around the world 250 times? No matter which adventure you choose, you will cover roughly 6 million miles. That's exactly how many miles GSU's Aviation Department has flown since its creation in 1957...without a single injury or accident.

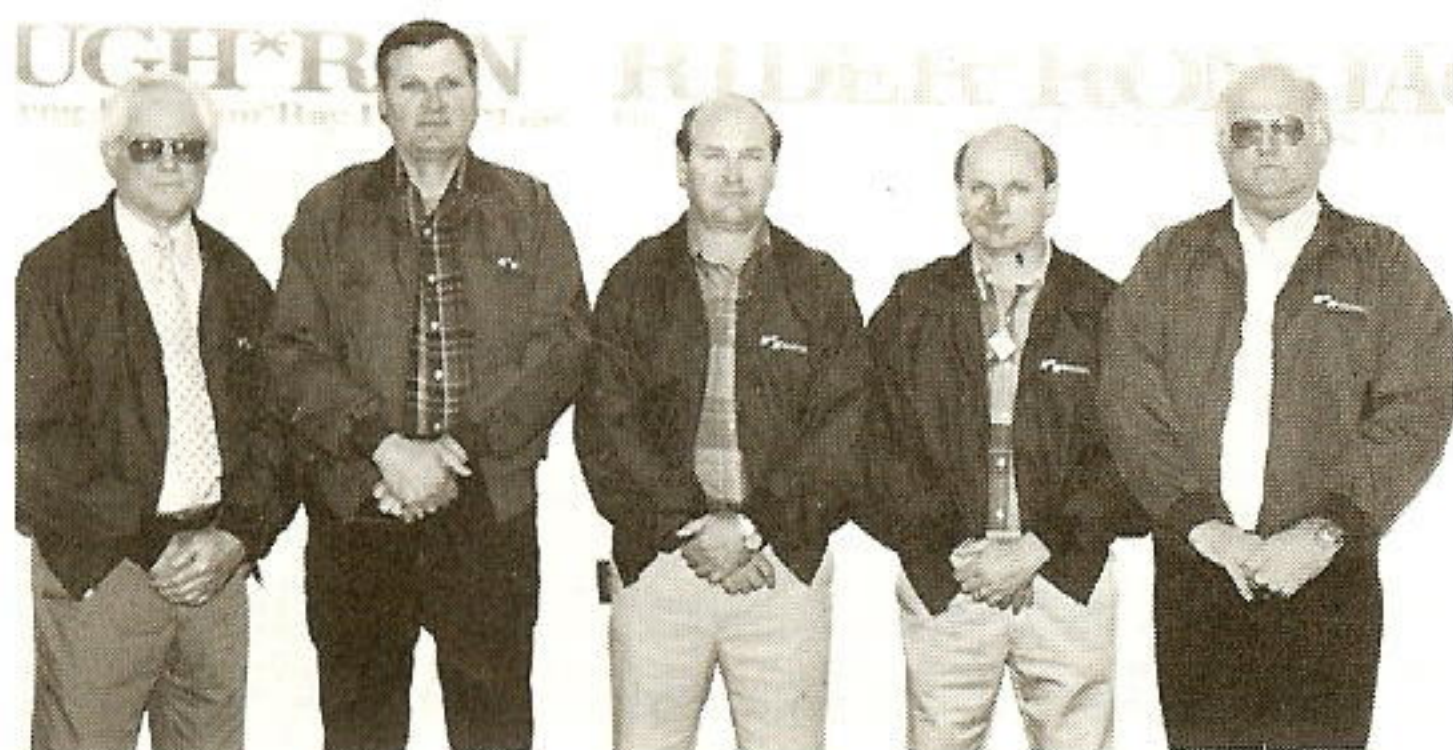
Floyd Crow, chief pilot, firmly attributes the perfect safety record to "training and conscientious people who are dedicated to safety."

"All of our pilots go to recurrent training every year and are reviewed in all emergency techniques and procedures," he says.

The Aviation Department, located at the Jefferson County Airport, is responsible for transporting GSU personnel throughout the system and across the country if necessary, as well as patrolling transmission lines. Currently, the department leases three planes: a Lear 35 and a King Air E-90 for business travel and a Partenavia P-68 for line patrol.

Since its inception, the department has leased more than 10 planes. "We don't own any planes, they're all leased," Crow says. "We leased our first plane in 1958."

6,000,000 MILES OF SAFE FLYING SINCE 1957

Talking with GSU pilots, it's easy to understand how they achieved 6 million miles of safe flying.

"Safety is the bottom line," says Jim Killough, senior pilot. "We must always be prepared for an emergency."

Tom Hargrove, pilot, agrees, "Safety is number one on the priority list."

Killough, who has been piloting 30 years, continues, "You have to stay one step ahead of the plane. You have to have a plan already in place in case something goes wrong." He says every take-off is predicated on engine loss.

"We'll go up for training purposes and fly with one engine turned off," Hargrove says. "However, I've never lost an engine."

Hargrove's missions have a bit more adventure than basic shuttles to Baton Rouge. When flying line patrols, his aircraft flies at tree-top level.

"I'm flying about 150 feet above the ground," the Air Force veteran says. "It's similar to aerobatic-type flying."

Weather conditions are constant variables pilots must monitor. "We try to plan around the forecast but with the weather, you never know," Killough says.

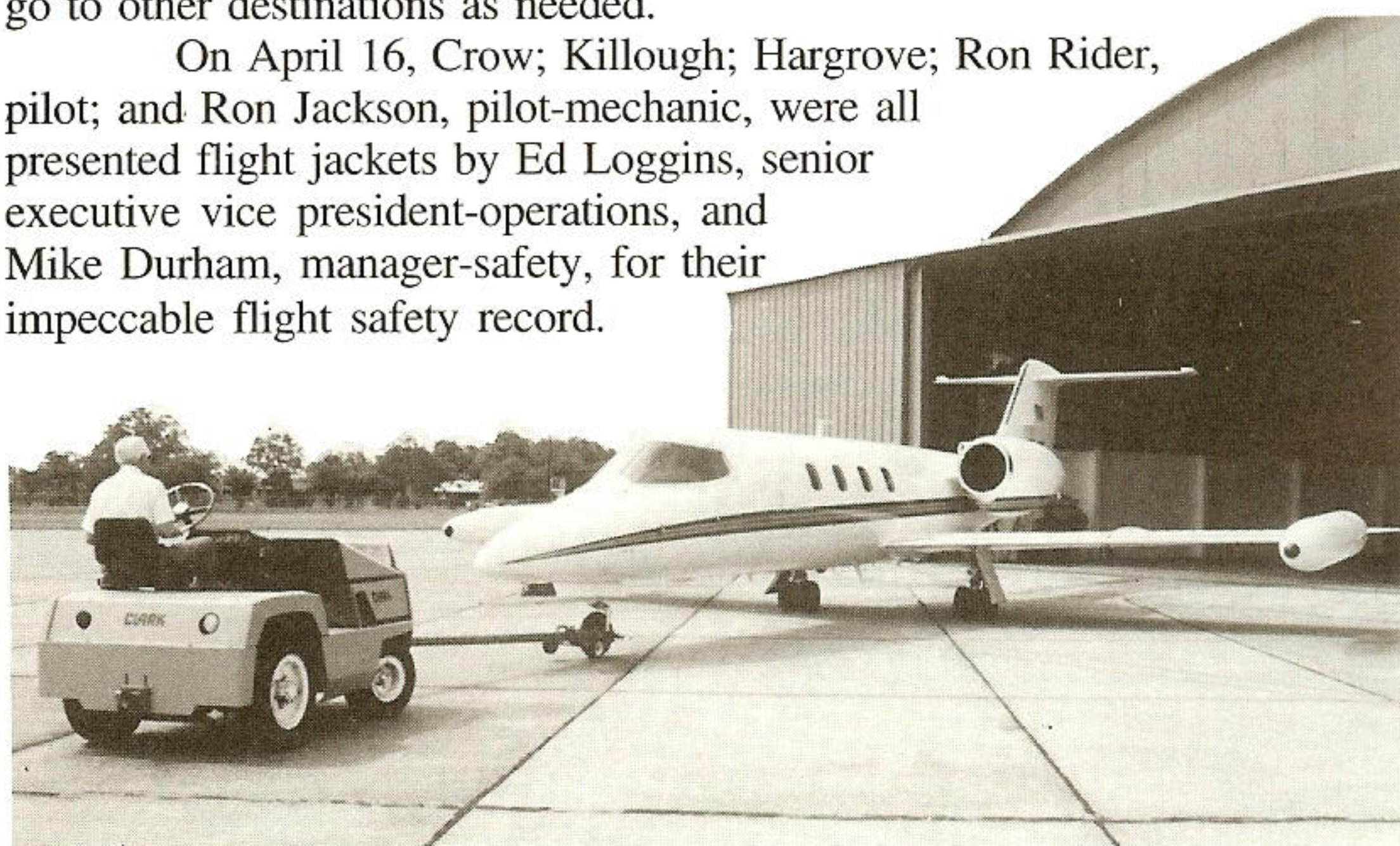
In particular, wind and heat cause low-level turbulence, an obstacle Hargrove doesn't want to meet along the tree tops. The heat causes the air to rise which can get gusty at lower altitudes. "That can get uncomfortable at times," he says with a smile.

According to Crow, the transportation planes travel primarily to Baton Rouge, with at least three round-trip flights per week. The planes go to other destinations as needed.

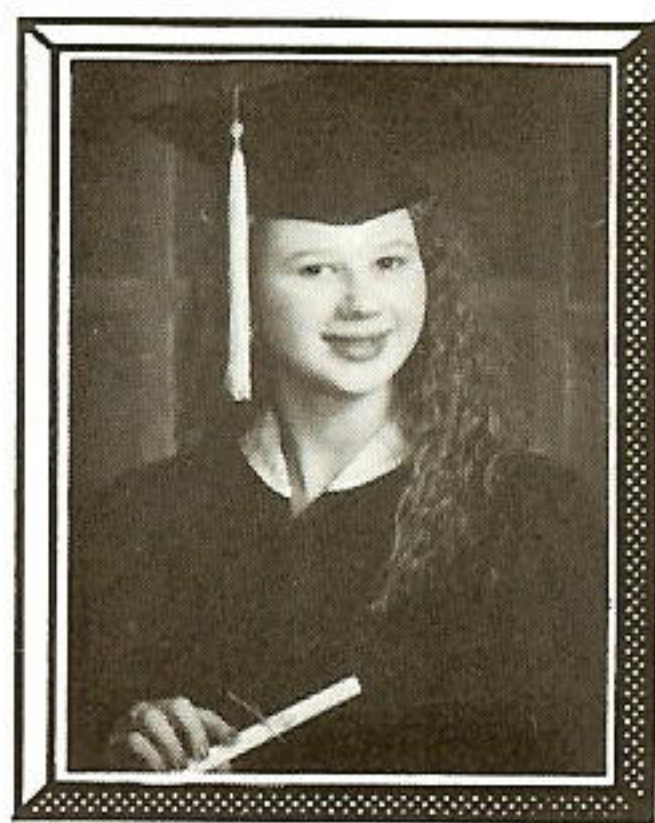
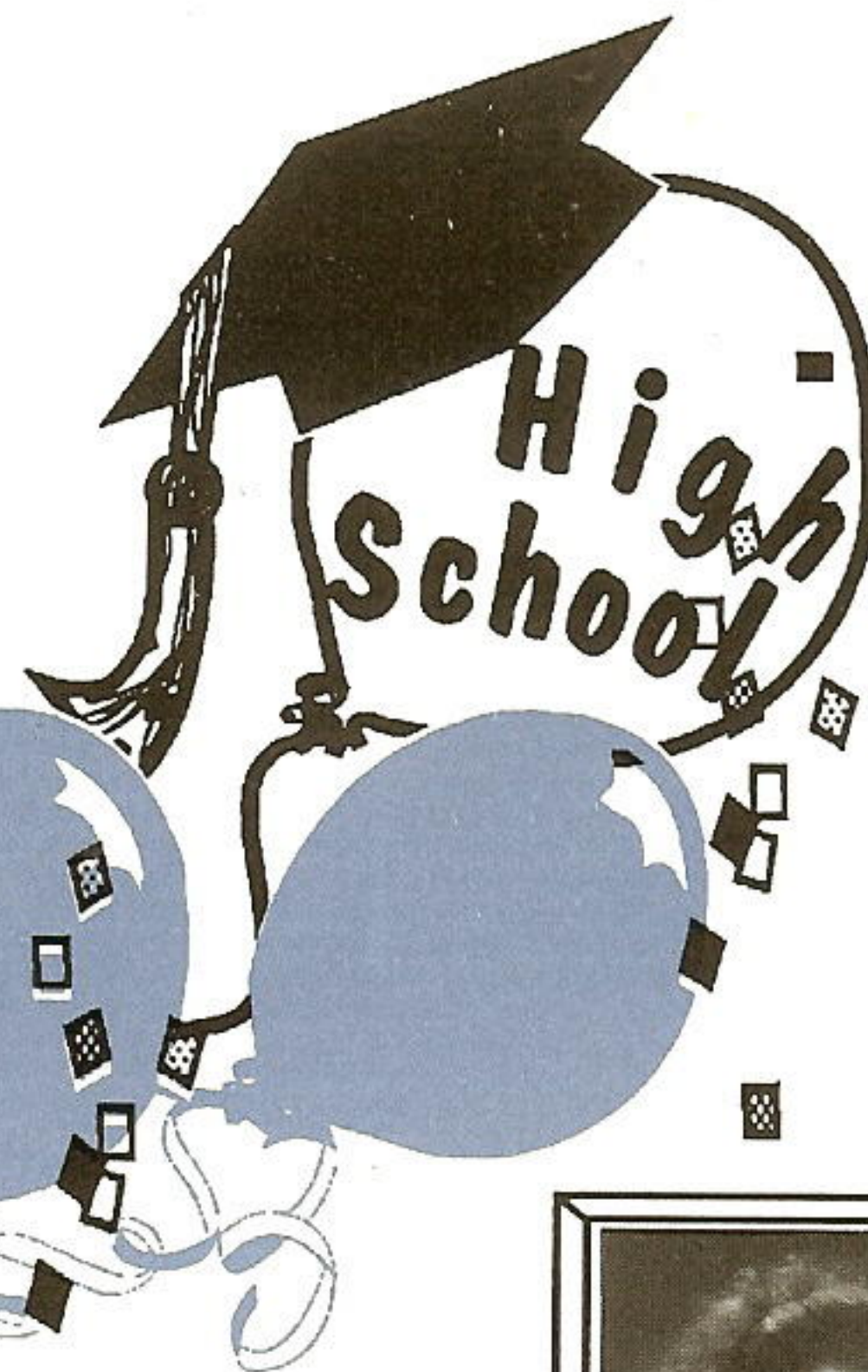

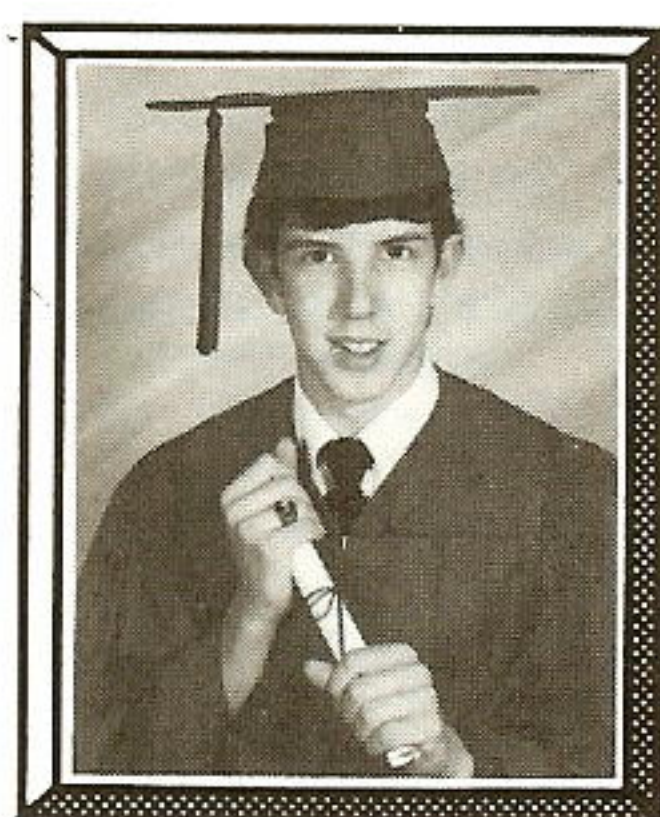
Inside the Lear jet, any of the seven potential passengers have a birds-eye view of the cockpit.



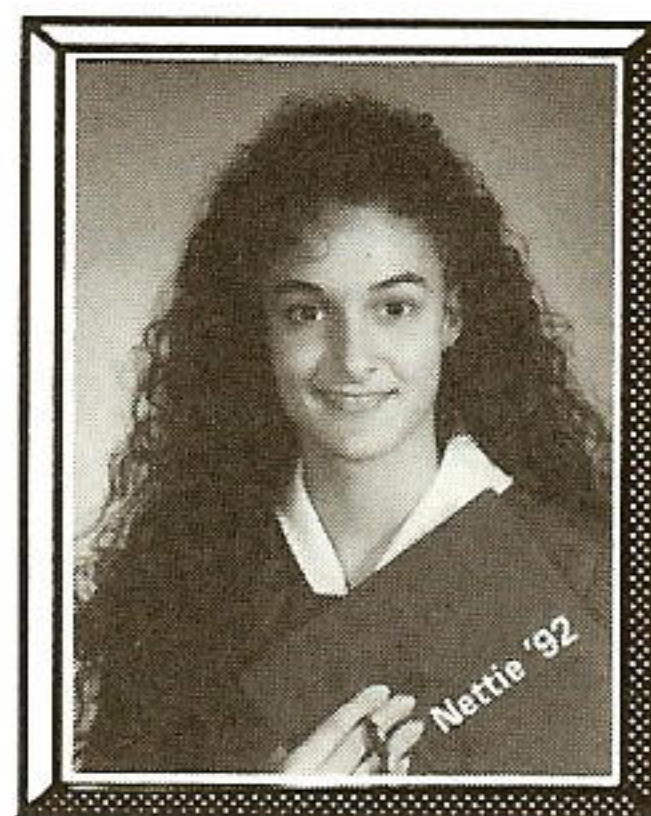

It is highly unusual for a company magazine to be older than its company.

But, as its readers can plainly see, **Plain Talks** is older than Gulf States Utilities. GSU was born August 25, 1925. The company magazine (once called the "house organ," an antiquated and disliked expression) came to light on June 1, 1922.

Other things are unusual about the early days of **Plain Talks**. Its name, for instance. Believe it or not, the first editor of the magazine was an electrical engineer named Reid Carlisle. It's difficult to imagine an engineer becoming an editor, much less coming up with a name like **Plain Talks**, or **Just Plain Talks**, as the early editions were called.

Rumor has it there was some argument within the corporate family about the grammatical correctness of the magazine's moniker. Reid's wife, June, who was for many years executive secretary to long-time GSU President Roy Nelson, was also an English language puritan.

"Reid, dear, you may call it 'Talking Plainly' or perhaps 'Straight Talk.' But 'Plain Talks'? That's ungrammatical," she might have said.

But **Plain Talks** it was. And is.

Thereafter, for many years, under the wise leadership of editors like Carlisle, Kenneth Sutton and Jerry Stokes, **Plain Talks** grew and prospered along with Gulf States. True, the magazine did not appear

every month; the editors had other assignments besides the magazine to occupy their days. Also, the size and format were a bit inconsistent during those formative years.

After World War II, however, the company was expected to settle down, get back to normal and gear up to try to weather the post-war business doldrums predicted by the sage economists of the time for southeast Texas and south central Louisiana.

Instead of a downturn, the area's economy skyrocketed, riding the crest of an oil and petro-chemical boom that lifted GSU into the ranks of the elite among the Fortune 500, right along with its blue-chip industrial customers.

Plain Talks prospered, too. Its staff increased, its photography and artwork improved and its pages were filled with award-winning prose about the company, its employees and the area it served.

Seventy years have gone by, and that tradition continues. A bit leaner, not as much color on its pages, but infused with youthful vigor, **Plain Talks** dutifully reports company news and remains loyal to the old three-legged stool ideology—employees, shareholders and customers.

Happy 70th birthday, **Plain Talks**! And many more.

Jim Turner is a GSU retiree living in Beaumont. He is a former manager of advertising and public relations and, for many years, was the editor of Plain Talks.

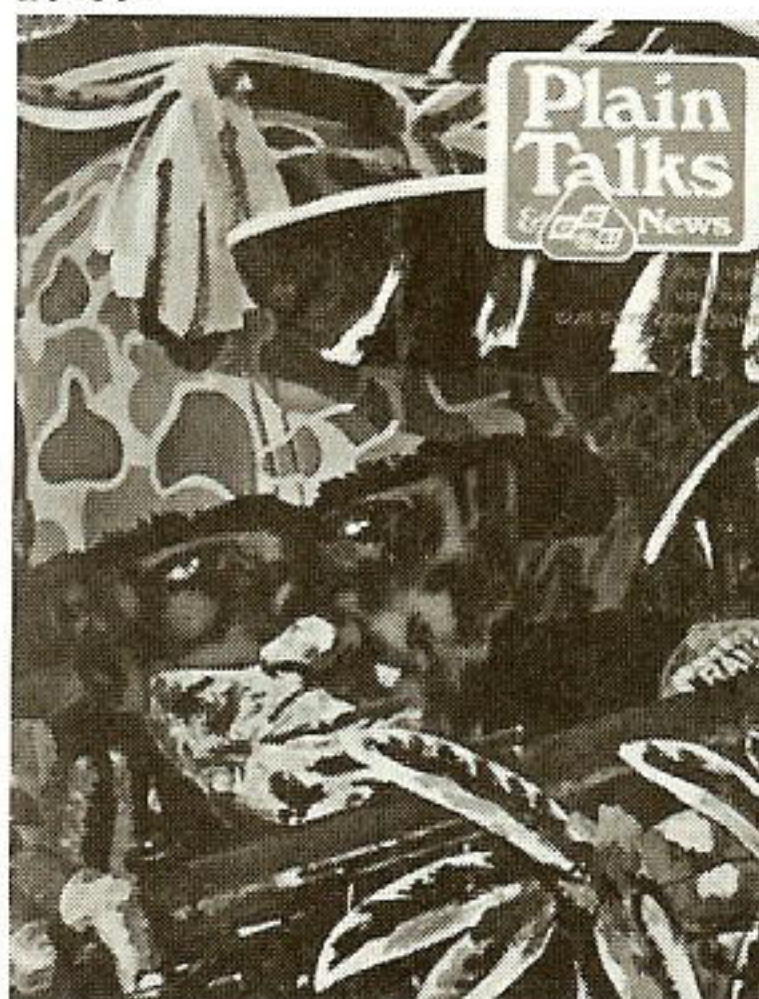

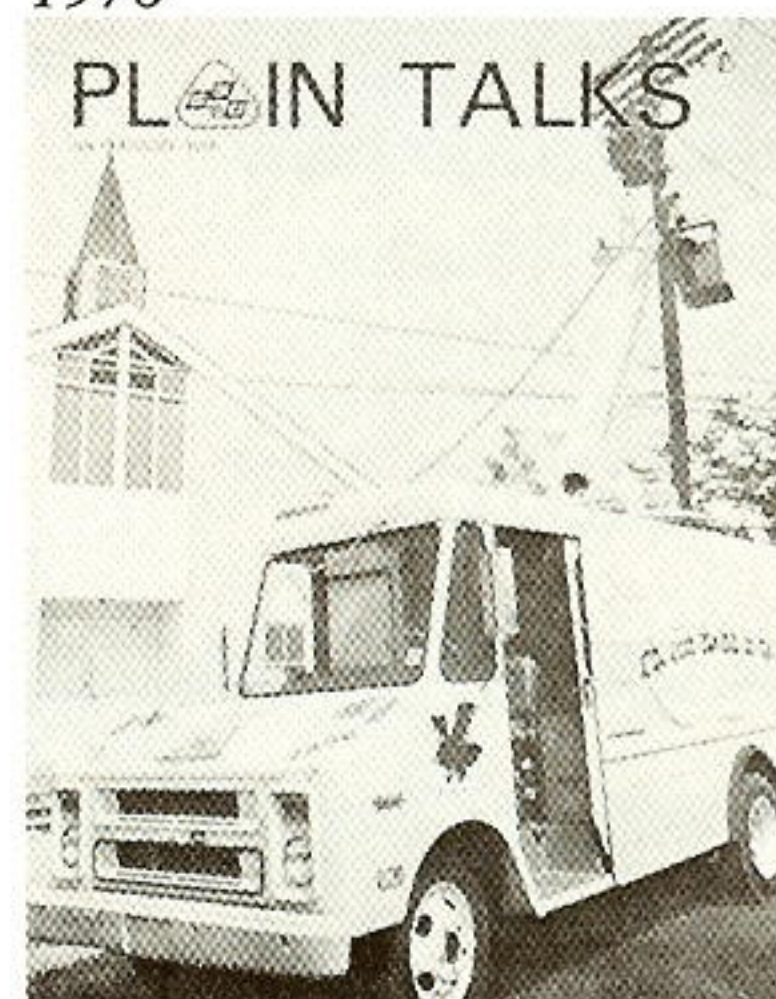

Lake Charles celebrates Christmas in April

GSU Reddy Volunteers from southwest Louisiana participated in "Christmas in April," a community wide, one-day blitz to repair and improve the homes of the low income, elderly and handicapped. The project is dedicated to keeping these homeowners living in warmth, safety, independence, dignity and decency.

Fifteen homeowners celebrated Christmas in April Saturday, April 25, thanks to volunteer efforts. The event was sponsored by the Junior League of Lake Charles and repairs were performed by teams of local volunteers, including GSU Reddy Volunteers, who caulked and weatherstripped all 15 homes.

Clyde Mitchell, customer affairs coordinator, Lake Charles, serves on the Christmas in April community board of directors. Coordination efforts and selection of homes are the primary responsibilities of the board. He also coordinated Gulf States' volunteers for the project.

Christmas in April is a national organization launched in 1983 and since then has involved 144,000 volunteers in the rehabilitation of 8,100 homes across the nation. Lake Charles area homeowners are already calling and requesting help for next year and GSU's volunteer team is making plans to adopt a home.

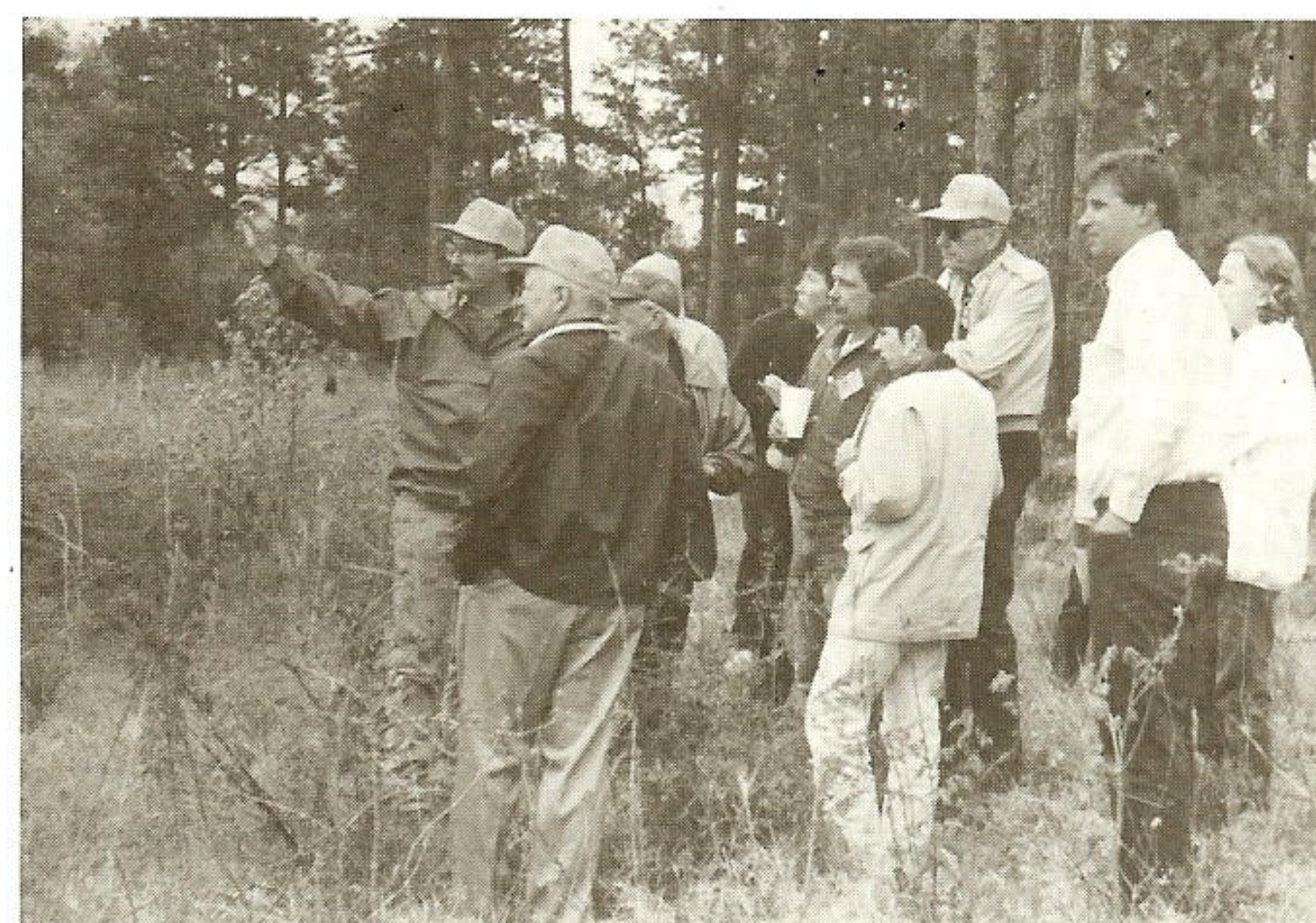

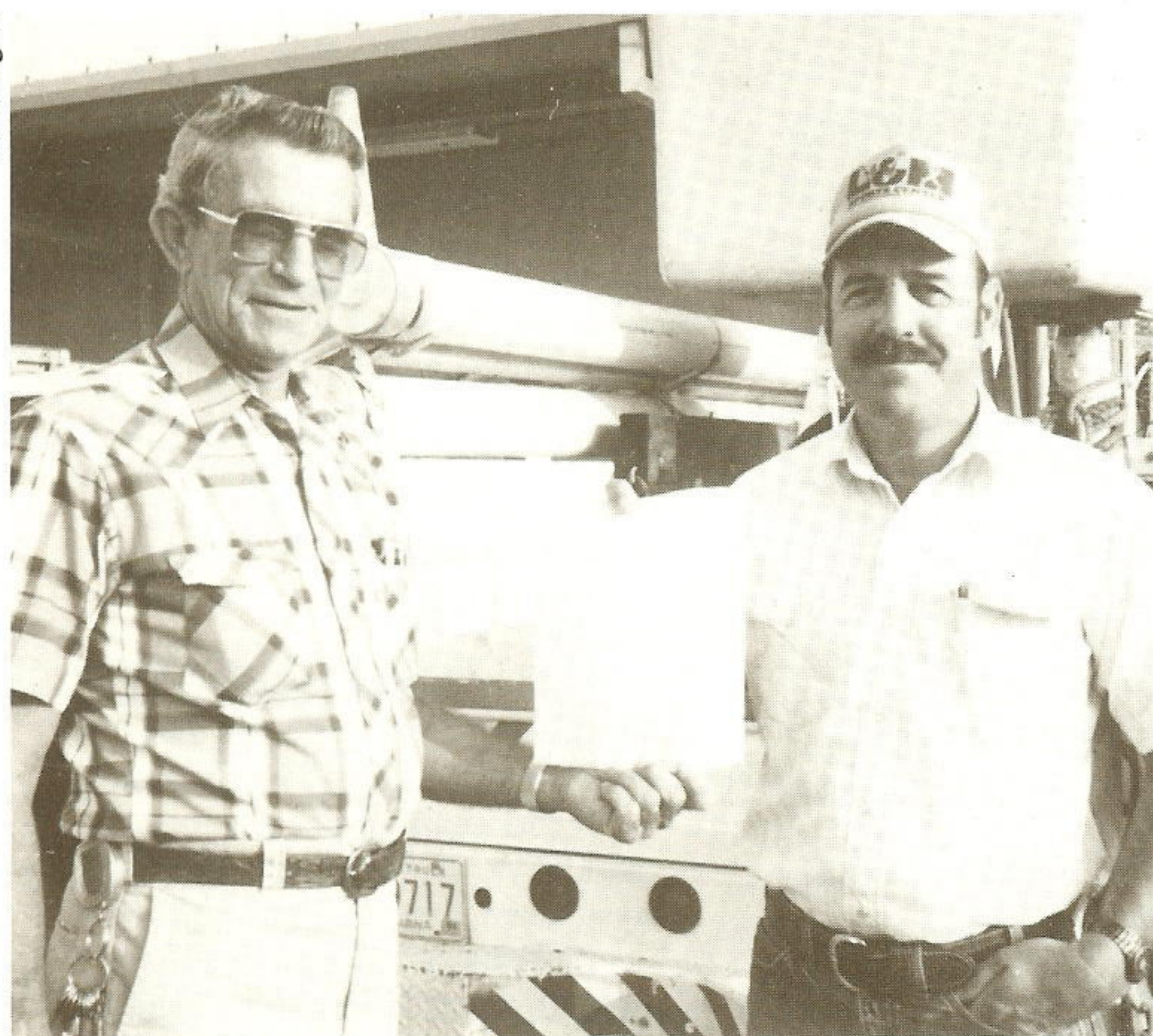

Countdown to communication

It will take time for many Gulf States employees to sort out their feelings about the proposed merger with Entergy Corp., but at least the sorting isn't being done in the dark.

Keeping employees informed as the merger process goes forward is a high priority with GSU Chairman Joe Donnelly and Entergy Chairman Edwin Lupberger.

The two chairmen thought it was especially important for employees to hear the initial news of the merger agreement from the two companies instead of through the news media.

That wasn't easy, but it was worth it.

The merger agreement was signed by Donnelly and Lupberger about 7:30 p.m. Friday, June 5. Federal disclosure requirements called for the public announcement to be made at 7:30 a.m. (GSU time) Monday, when the New York Stock Exchange opened.

That posed a formidable challenge in terms of getting the word to employees as they arrived at work Monday morning. Some preliminary communications work had been done in the event that the two companies' boards reached agreement. (My office door had been closed so long, this sign appeared shortly after the merger announcement was made: "First the Red Sea parted. Then the Berlin Wall came down. And now Kim's door has opened!")

But nothing could be completed or produced until an agreement was actually reached. The 59 or so hours between the time the agreement was signed and the announcement was made were an extremely intense period of activity.

Two Entergy communications people arrived here shortly after the merger agreement was signed and we worked until 10 p.m. Friday night, putting the finishing touches on many of the communications pieces. The Entergy people flew back to New Orleans late Friday night to start producing the briefing books, media packets and employee information kits.

Among the materials that had to be completed, reviewed by the management and attorneys in both companies and reproduced were news releases, fact sheets, talking papers, anticipated questions and answers, brochures and letters.



As the process continued Saturday morning, a special challenge was posed by the two CEOs' desire to tell employees about the announcement in the most direct and personal way possible. Since they couldn't be everywhere, they decided to do a video that could be shown to all employees as early on Monday as possible.

At mid-day Saturday, I flew with Joe Donnelly and several senior officers to New Orleans, to videotape an interview with the two CEOs. When the officers flew back to Beaumont, I remained at the Entergy offices until Saturday evening working to complete the various pieces of the communications puzzle with assistance from my secretary, Marilyn McGraw, in Beaumont.

Entergy employees worked around the clock that weekend to put together thousands of employee information packets for shipment to Beaumont and Baton Rouge for further distribution to GSU locations.

At a special officers meeting at 3:30 p.m. Sunday, Joe Donnelly told the group the agreement had been signed. Each officer was asked to take enough information packets for all employees; copies of the videotape also were provided. A follow-up session was held for those who would disburse the information to employees or discuss the agreement on Monday with the media, political and regulatory contacts and key industrial customers.

By the time the Sunday meetings and briefing sessions were over, it was nightfall. That didn't leave much time for the packets and videotapes to be sent to various work locations for early Monday release, but the division vice presidents did the best they could.

It wasn't perfect. Ideally, all employees should have heard the news from their supervisors. But, since the public announcement had to be made at 7:30 a.m., that wasn't possible. Some employees heard it first on a morning newscast or were surprised by an Edison Plaza speaker announcement concerning the videotape.

But, given the amount and timeliness of the materials employees received as the announcement was being made, the CEOs' mandate to inform employees first should be obvious.

As the merger process moves ahead, there's much more to come. Stay tuned.
