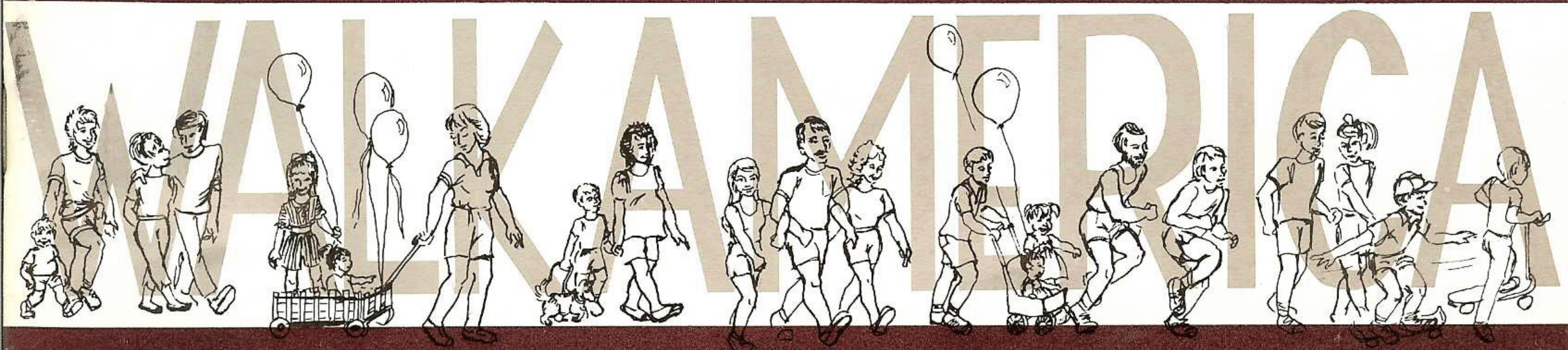

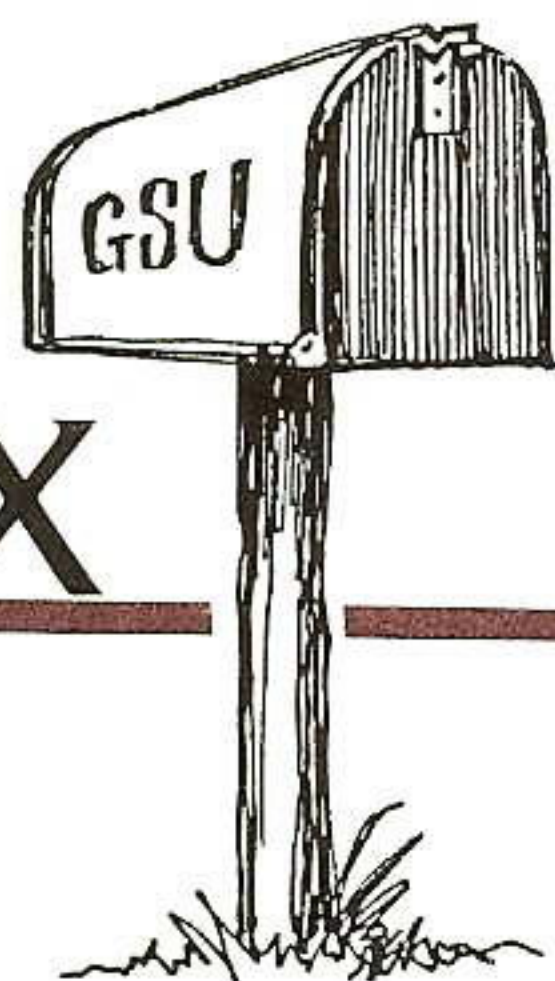

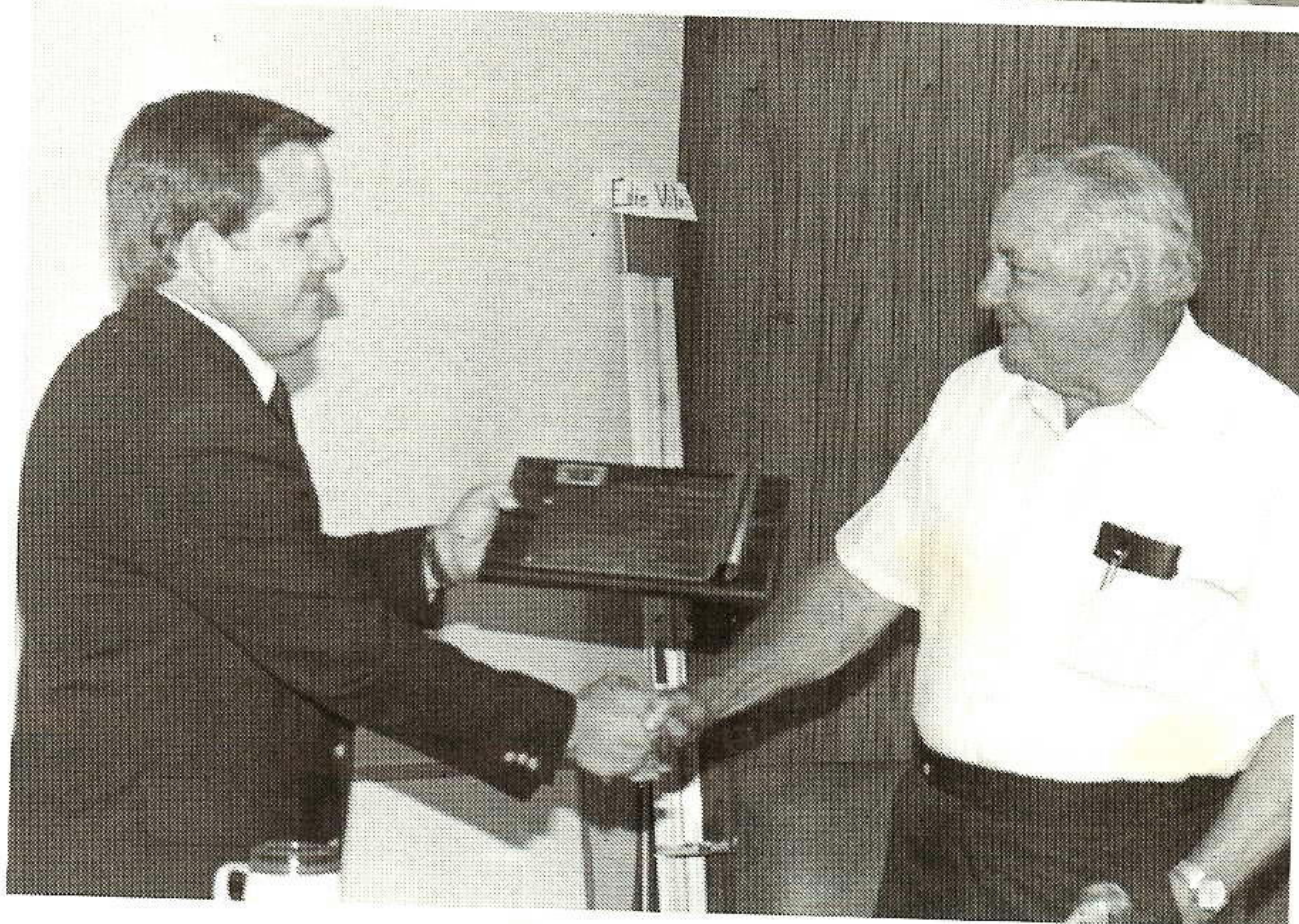

Looking back, looking ahead

"The most significant accomplishment was simply making it through calendar year 1988," said Dr. Linn Draper, GSU chairman and president, speaking to several hundred shareholders at the 1989 Annual Shareholders Meeting May 4. Looking back, Draper noted that it was a time of both significant accomplishments and some significant disappointments.

At the beginning of 1988, the company made a forecast of its financial position on a day-to-day basis. Those forecasts revealed that, with the rates in effect on Jan. 1 of that year, GSU would take in less revenue than it would spend. Permanent rate increases in both Texas and Louisiana provided a measure of welcome financial relief. "We made it through 1988 with \$100 million in cash. We're not well, but we've made progress," he said.

Draper looked with satisfaction on the performance of company stock prices in various classes in those 12 months. In May 1988, common stock sold for \$5.25 per share. Today, it is around \$10 a share, an appreciation of 90 percent. The various classes of preferred and preference stock appreciated from 42 percent to 60 percent over the same period. "The price of none of these classes is where we would like it to be, but

the appreciation is significant and a recognition that the public believes we will survive," he observed.

The bright cloud of news about stock performance contains a dark lining — dividend payments. GSU has not paid a common stock dividend for 11 calendar quarters. No preferred or preference dividends have been paid for 9 calendar quarters. Draper called this "a serious matter," and added that it remains uncertain when payments will be resumed.

Looking ahead to challenges in 1989, Draper listed the following: Dividend restoration; resolving the disagreement with the Southern

Company; a possible legal dispute with Cajun Electric over River Bend costs; preparing for contingencies and facing business competition. He projects 1 1/2 percent load growth for GSU this year and a construction budget of less than \$75 million. Draper said he believes GSU's cost of doing business will stay even with inflation if the economy remains steady. He added a strong message of caution. "Our condition has improved some, but it is still precarious. For 1989, 1990 and 1991, we will still take in less money than we pay out."

New program targets senior customers

Imagine yourself in your 60s, living on retirement and social security. You have seen inflation over the years erode your fixed income's buying power to the point you no longer are able to pay all of your bills each month. You must choose which ones to pay. Given the choice between paying a medical bill, buying food or paying your utility bill, which would you choose?

If you choose to pay your utility bill first, you fit GSU's typical elderly customer, says Jo Ann Smith, manager - community affairs. "Our elderly customers have been some of our best paying customers. They have a strong work ethic. Timely bill paying is a high priority. If they must choose which bills to pay first, usually the first choice is their utility bill, medicine, then food."

Addressing the needs of our elderly customers has become more significant. Thirty-five percent of all GSU customers are at least 55, well above the national average of 21 percent. More than 25 percent are age 60 or above. "We have begun segmenting customers and aiming messages at specific groups," says Smith. "The elderly segment will grow and increase in importance because an additional 36 percent of our customers fall in the 25 to 55-year-old bracket."

In the past, GSU aimed its programs-for-seniors primarily at those customers in crisis situations. These programs included Third

Party Notification, Gatekeeper and Project CARE. As of March 31, Project CARE had assisted nearly 28,900 households, according to Don Pumphrey, senior public affairs representative, and Project CARE Coordinator. The program has paid out about \$1.9 million to help elderly customers with their utility bills during times of emergency. During the recently completed campaign, GSU employees increased their pledged contributions by almost 10 percent. To date, employees have contributed about 25 percent of all Project CARE funds.

But, Smith says a large portion of the elderly segment of the customer base is not in a crisis situation. The company has looked at ways to service the needs of all senior customers, including the more fortunate ones.

SeniorWise, a program of services for savvy senior customers, offers several free services to all GSU customers age 60 and above. GSU announced the program using May bill inserts sent to all customers.

Services available for seniors who fill out and return the enrollment card include:

- Get Well First, automatic special handling of a customer's account which avoids disconnection during hospitalization.

- Third Party Notification, which notifies a friend or relative of an overdue bill to avoid having the customer disconnected.

- Lighting Installation Rebate,

money saving rebates on outdoor security lighting.

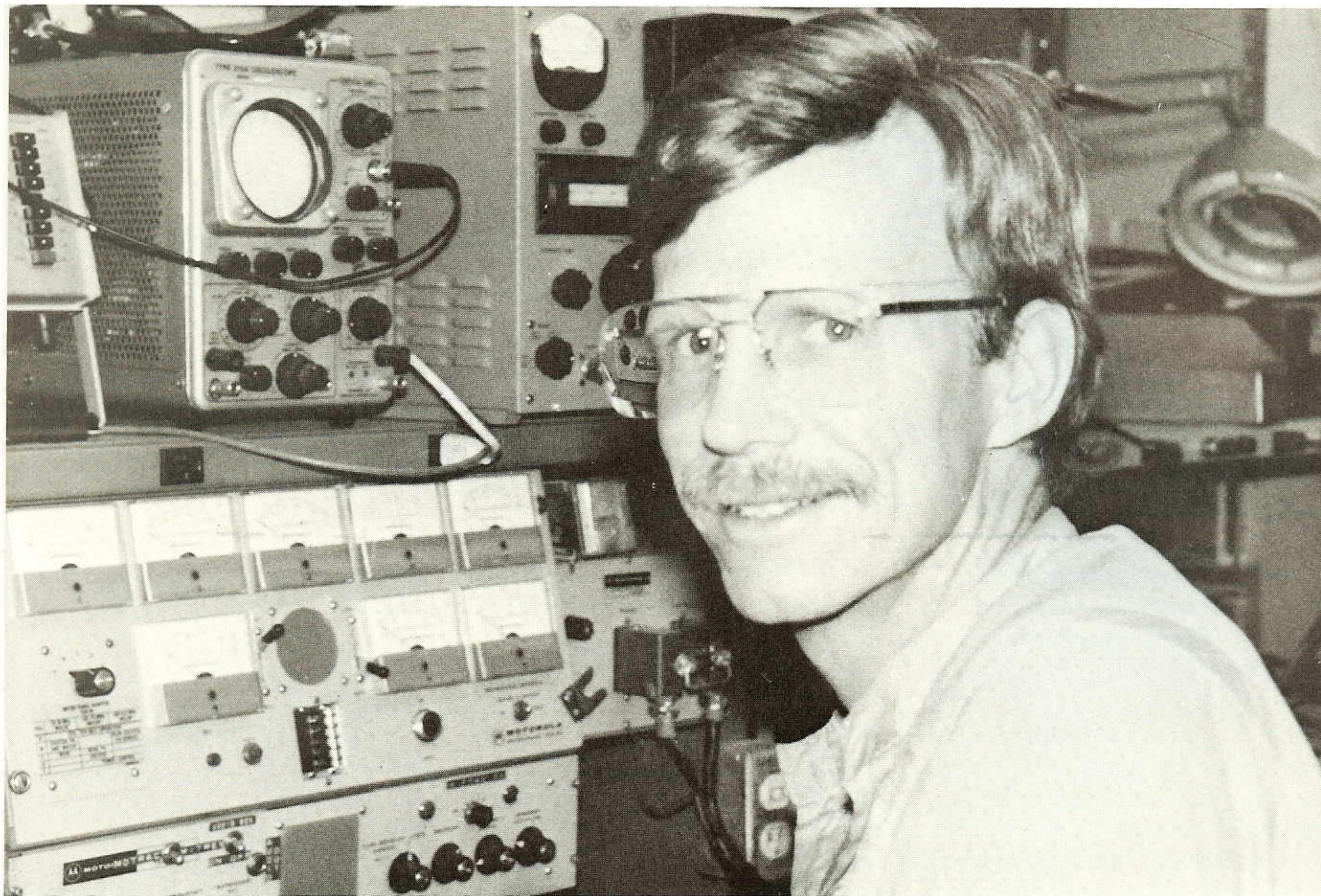
- Free Energy Audit, information on how to save energy dollars in the home.

- Large Print Bills, where the amount due and due date are printed in large, easier-to-read type.

- SeniorWise Newsletter, published twice a year, with educational and informative articles about health and other issues.

SeniorWise combines with other GSU programs aimed at the elderly, including a \$7 discount for customers aged 65 and above with incomes of \$10,000 or less. Filed with the current Texas rate case, Smith says this would be an ongoing money saver for our elderly customers. "The senior citizen discount appears popular with all of our customers," she says. "Our survey showed more than 85 percent would support the discount and 78 percent were willing to pay 50 cents more to help pay for the discount."

Smith characterizes the typical elderly customer as honest, hardworking, proud and independent. "Aware that this segment of our customer base will continue to increase in size, we are looking at other programs we can implement to meet some of their special needs," she concludes.

If you have spare time, what do you like to do? Some may go fishing, play with their children, do yard work, take it easy or catch up on some hobby work.

When Zach Olson, communications serviceman-1st class, Lake Charles, has spare time, he volunteers.

“If I have some time off, I’ll call up the volunteer center,” says Olson. “They know what I like to do and their computer gives me a bunch of names I can call to see if I can help.”

Olson volunteers through the Southwest Louisiana Volunteer Center, an organization that matches volunteers with specific jobs.

“The center is a good idea and very effective,” says Olson. “They match your skills and abilities to their need. They’re not going to have you do what you can’t do.”

Olson’s volunteer work is centered around electronics.

“I’ve changed out light bulbs and fixtures for Abraham’s Tent, a food bank that feeds the hungry, and I’ve done some electrical projects at the Children’s Museum,” says Olson.

One of the museum projects includes rebuilding an electronic organ.

According to Olson, the museum director started building the organ and the children played with it and took it apart. The director called Olson and asked him to put it back together in a way the children couldn’t take it apart.

“It didn’t work for me either,” laughs Olson. “Children can take anything apart!”

Olson got interested in volunteering by noticing the volunteer center’s advertising.

“They sounded like they really needed some people by the way

they were actually advertising on radio, TV and in the newspaper,” says Olson. “I thought I would give it a chance and help them out.”

Olson feels volunteering is not only fun and interesting, but necessary. “If we didn’t have volunteers, there would be a lot less things we could go to,” says Olson. “There are a lot of churches that have festivals and if they didn’t have volunteers, they wouldn’t have any workers.”

Olson enjoys volunteering and has found it to be self-fulfilling. “I think everyone should try it once.”

What is Olson’s message to other potential GSU Reddy Volunteers?

“Go out and try it, you might like it. If you don’t like it, you’ve only lost a little time. If you’ve got the time and you want to do it, volunteering is a good thing to do.”

Kyle Todd, chief distribution planning engineer, Beaumont, and system coordinator for the walk says the effort was a big success. "We had more employees partici-

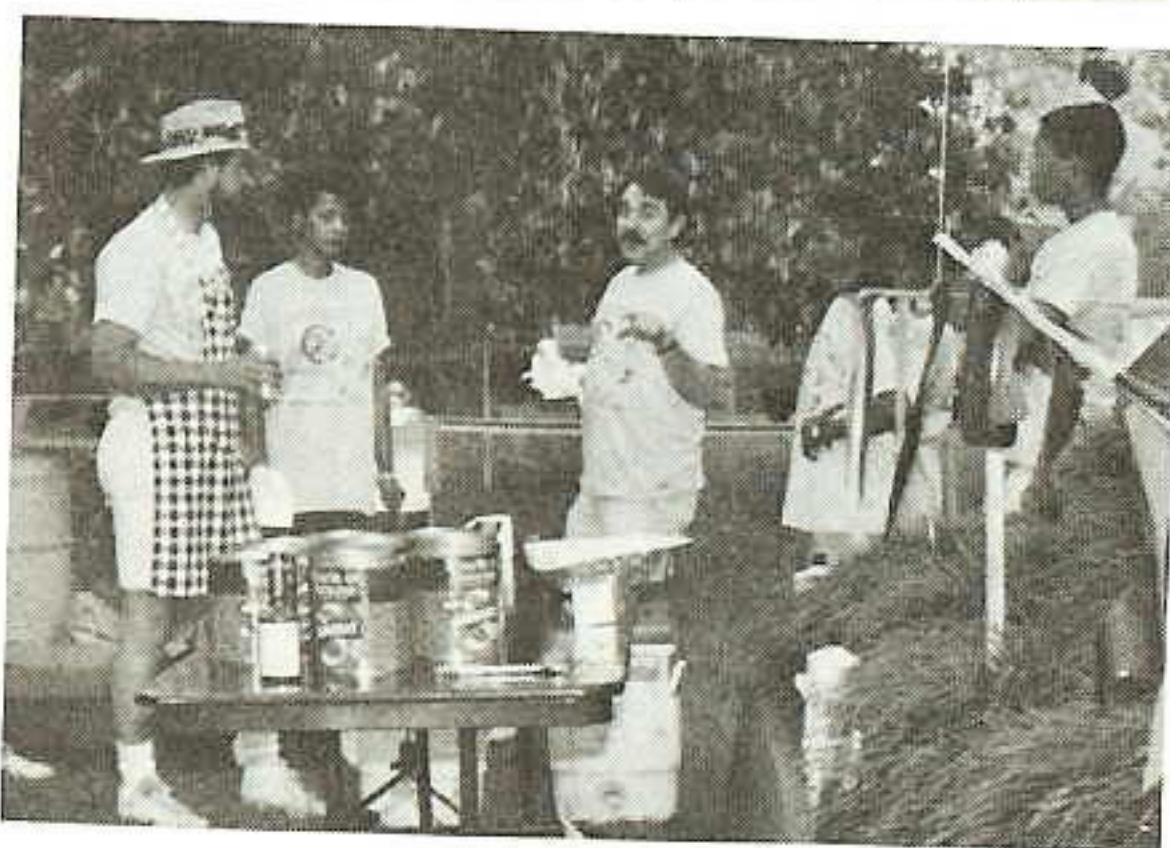
pating this year," says Todd. "It was great. The weather was good in every division."
