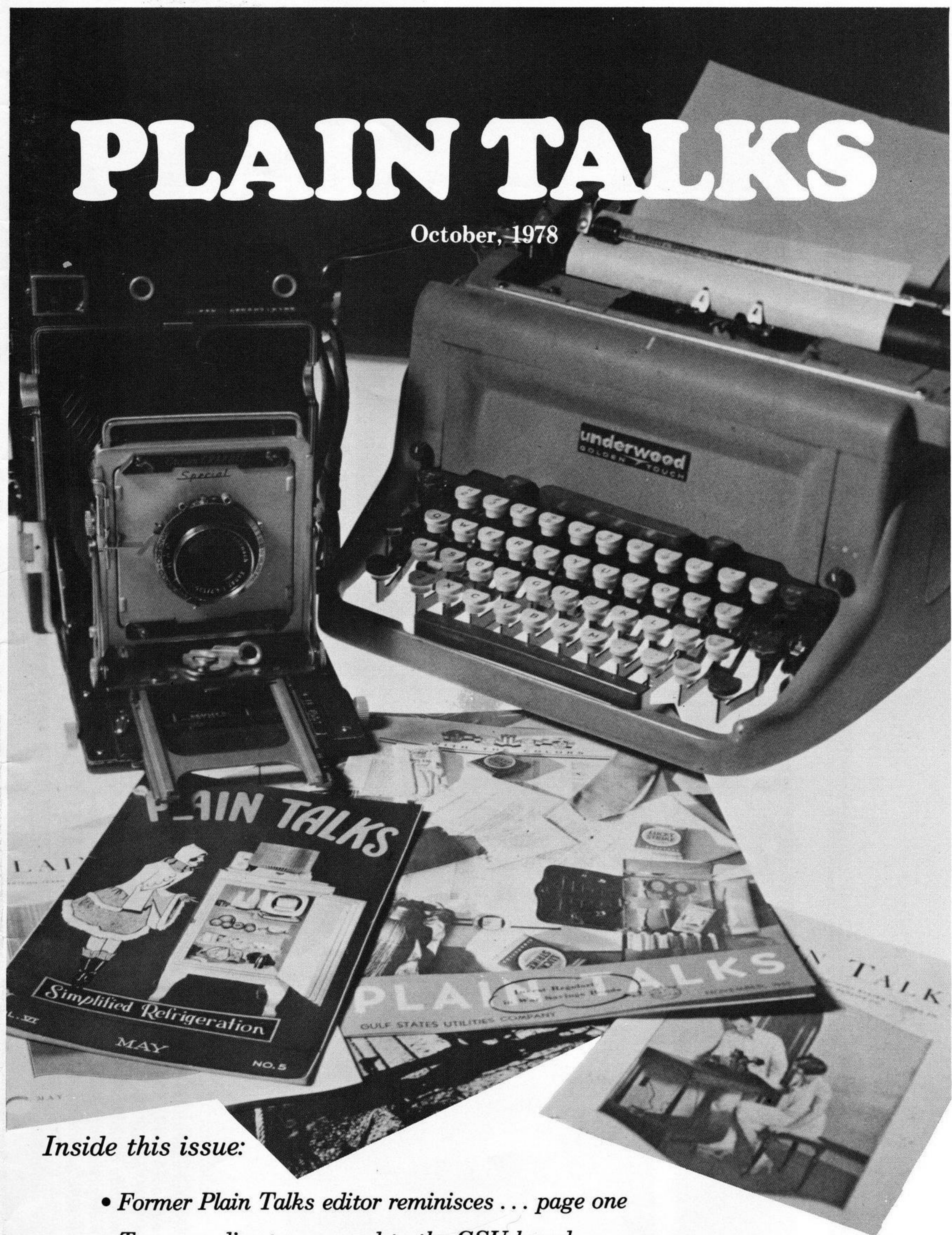

A voice from the past

Former 'Plain Talks' editor looks back

This issue marks the first time in some 57 years that Plain Talks has not been published in a magazine format. In view of all the changes occurring within GSU, Plain Talks editor Gary Dias thought it would be a good idea to have a talk with someone who knew the company in its infancy. The following article is the result of the recent conversation he had with one of the original Plain Talks editors.

Change. Gulf States Utilities Company has seen a tremendous amount of it during the more than 50 years of its existence and one man, Kenneth Sutton, has seen most of it first hand.

Sutton, a former newspaper man, joined the company in 1926 as editor of the employee magazine, *PLAIN TALKS*, something he had a hand in until his retirement in 1965 as director of advertising and publicity.

"I was a one-man band," grinned Sutton as he spoke of his early years with the company that was to become Gulf States Utilities. "I used to do a lot of traveling in those early years and I knew everybody. That was one of the nice things about the job."

A native of Beaumont, Sutton was born "around the time of the Spindletop oil boom." Before beginning his lengthy career with the newly created GSU, Sutton worked on the staffs of several newspapers.

He was hired as a cub reporter by the New Orleans Item in 1919 and later worked on the editorial staffs of the New Orleans States and the Times Picayune, the Milwaukee News and the Newark (New Jersey) Ledger.

"I remember my first assignment with the Item," recalled Sutton, reaching for a cigarette. "It was on a dark night on Tchoupitoulas Street. A girl got in a fight with her boyfriend and stabbed him and I was sent out to cover it. I came back to the newsroom, sat at my typewriter, wrote a lead, tore it up, wrote it again and tore it up again."

Upon bringing the problem to his managing editor, Sutton was asked what the story was about. "So I told him that a girl got mad at her boyfriend and stabbed him on Tchoupitoulas Street. The managing editor said 'It's simple. Why don't you just say so?' That's when I learned to write a lead," said Sutton smiling.

Sutton returned to his native Beaumont in 1924 and became a reporter for the Beaumont Journal. He joined the six-month-old GSU on

January 5, 1926, to edit *PLAIN TALKS* and handle the company's advertising and publicity.

Despite the more than half a century that has elapsed since the inception of *PLAIN TALKS*, Sutton tells about its beginning like it happened last week.

Pete McChesney, sales manager of Gulf States' predecessor company, started the publication in 1922 with the name *JUST PLAIN TALKS*. GSU was not incorporated until 1925, the year before Sutton arrived. "Before that, the company was just Beaumont and Port Arthur," he remembers. "Then we began to build 'big' power plants and transmission lines.

"It had a very appropriate name," Sutton

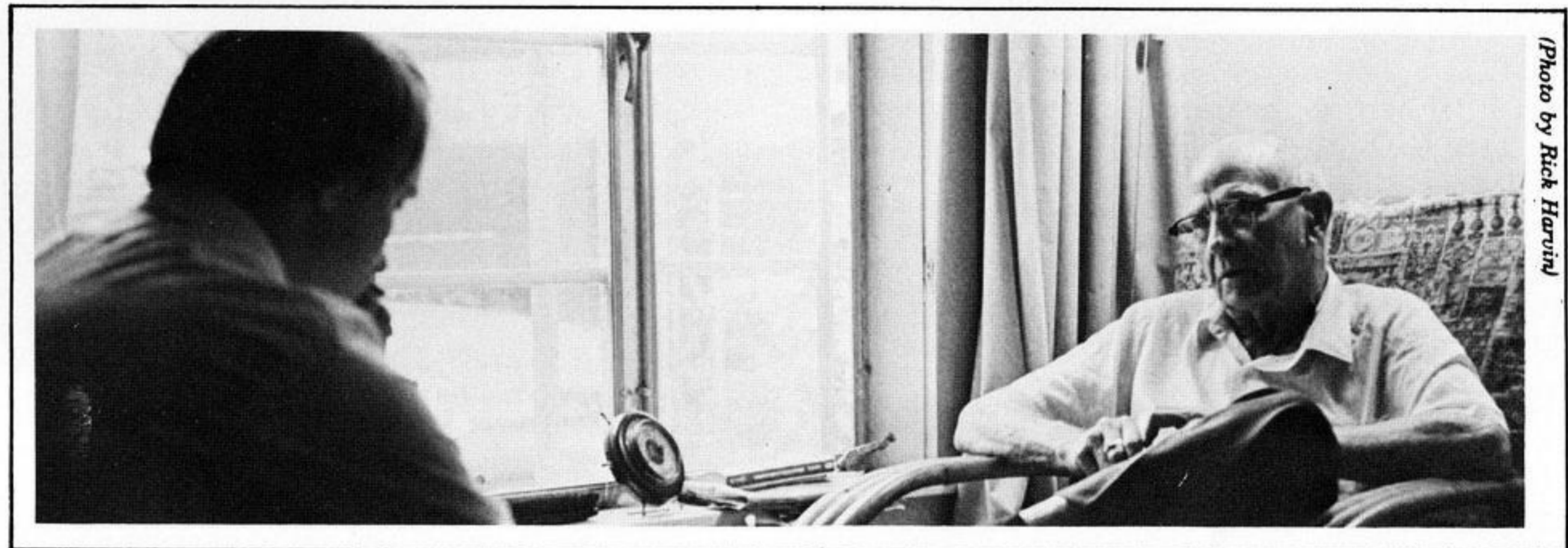
reflected, thoughtfully fingering his unlit cigarette, "because that's just what it was, plain talk".

"It's not really an appropriate name for the present publication," he mused. "On second thought, you do a lot more plain talking now than we did then. We didn't talk about things like politics."

In 1924, Reed Carlisle, McChesney's assistant, took over as editor and the title of the magazine was shortened to *PLAIN TALKS*. Two years later, Sutton took over as the magazine's third editor, a position he held for about 10 years before he was succeeded by Bill Hammond. "But I was actually responsible for it for forty years," added Sutton. "It was Bill who suggested the *Life* magazine format in the mid-thirties (which has endured until this issue).

"At any rate, *PLAIN TALKS* isn't the baby I inherited. It has become a very fine adult publication, fulfilling today's needs excellently," he said.

Shortly after joining the company, Sutton, who was also the company's advertising agent, began



working on a cartoon figure to personify electric service and came up with a saucy little character he called Aleck Tricity. "He was pretty smart aleck, but he was my baby," joked Sutton.

"He was pretty crude originally," admitted Sutton, who did the original artwork on the figure, which was basically a convenience outlet

Educator, banking executive elected to board

Dr. Paul W. Murrill, chancellor of Louisiana State University, and Nat S. Rogers, a Houston banking executive, have been elected to the GSU board of directors.

The appointments were effective October 1.

Murrill, the chancellor of the largest campus in the LSU system, became the top administrator at LSU following five years as vice-chancellor and dean of academic affairs.

A native of St. Louis, Murrill grew up in Clinton, Miss. He received his bachelor's degree in chemical engineering at the University of Mississippi and master's and Ph.D. degrees in chemical engineering at LSU.

He is listed in *American Men of Science* and

Who's Who as a teacher, an engineer, scientist, computer specialist, author, civic worker and Naval Reserve officer.

Murrill is the author or co-author of eight books in the fields of control theory and computers and has made contributions to other books. He is in continuous demand nationwide to teach workshops, short courses and professional development courses. In 1976, he served as the national vice president of Muscular Dystrophy Association, Inc.

A member of numerous professional and civic organizations, Murrill is an ordained deacon of the University Baptist Church.

Rogers, a native of Mississippi, is a graduate of Millsaps College and received his MBA degree from the Harvard Business School. He has been involved in banking since 1947, following service with the U.S. Navy during World War II.

Active in a long list of professional banking organizations, Rogers has served as president of the American Bankers Association, president of the Mississippi Bankers Association and president of the Southeastern chapter and national director of the Robert Morris Associates.

He currently serves as a member of the ABA Government Relations Council and the Government Borrowing Committee. He is a director of the Houston branch of the Federal Reserve Bank of Dallas, a trustee of Millsaps College, University of St. Thomas, South Texas College of Law, Southwestern University and Methodist Hospital. Rogers is also an active member and officer of the Chamber of Commerce, United Fund and the Better Business Bureau.

Morning Advocate editorial blasts La. PSC's discussion of GSU ads

The Louisiana Public Service Commission (PSC) continued its hearings on GSU's \$43 million rate case in Baton Rouge last month. One of the topics of the three-day hearings was the company's advertising program. The following editorial, opposing the inclusion of the advertising issue, appeared in the Baton Rouge Morning Advocate on Tuesday, September 26.

The Louisiana Public Service Commission has committed serious error in even opening the subject of regulation of the advertising of Gulf States Utilities Company.

So have Charles Tapp, head of the Governor's Office of Consumer Protection and Steve Irving, attorney for the Louisiana Consumer's League.

The question was raised at a recent PSC meeting whether the utilities firm was using what PSC officials termed "political" and "scare tactic" advertisements, particularly in reference to construction of the River Bend nuclear power plant north of Baton Rouge. Concern also was expressed whether GSU consumers were paying for the advertising.

One immediate problem is the definition of the words political and scare tactic. What may be considered by the PSC as an effort to frighten the public by predicting future power shortages may well be viewed by GSU — and the public — as simply telling the truth.

It is common knowledge that the section of Louisiana served by GSU is growing and that there will be a need for greater power generation capacity in the future. It also is common knowledge that the cost of energy has risen because of the increased cost of fuel and the general rate of inflation.

The most serious question that the PSC and its

chairman, Louis Lambert, have raised, however, is that of censorship — infringement on the First Amendment right to express one's opinion publicly.

The right to express one's opinion, in this country, includes the right to speak out for or against pending legislation, the right of a company to inform the public of its position — whether or not the advertisements through which this is done are "hard-hitting" or political in nature.

If the Public Service Commission takes upon itself the right to prohibit certain advertising, then what is to stop it from moving deeper into the censorship field in the future, demanding to see news releases and other publications of the utility firm before they are sent to newspapers, radio and television stations?

The answer simply is, nothing. Already, the attorney for the PSC has questioned the relationship of the utility firm's public relations officials with local news reporters — a matter that should be of concern only to GSU and the news people.

The Public Service Commission, as a public — though often too political — agency, supported by taxpayers' dollars, is supposed to function as a regulatory body. It is designed to protect the public's interest by seeing that proper rates are charged for utility services. It also is designed to allow utility firms to make sufficient profit to ensure uninterrupted service to the public.

It has no right to concern itself with the placement of advertising or relationships with the press, and the public should recognize what the PSC has done for just what it is — an attempt at censorship.

Varibus natural gas wells to be opened for production

Another of the natural gas wells in which Varibus Corporation has a substantial interest has been tested and proven productive and will be opened for production, along with six other wells, upon completion of a gas treating plant by United Gas Pipeline Company.

Varibus' revenue from these wells, located in Hancock County, Mississippi's Waveland Field, has been put at more than \$2.5 million.

Construction of the plant is currently underway and the plant should be in operation by January, said Ed Hodges, vice president of Varibus, a wholly owned subsidiary of GSU.

The gas from these wells will be sold to United Gas for sale in the interstate market, under terms of a contract executed on August 25 by Varibus and several other companies. "It's hard to speculate exactly what the gas will be sold for," said Hodges, "but it will be the maximum amount permitted by federal regulations, currently \$1.50 per MMCF (million cubic feet).

"How this will be affected by the pending energy bill is uncertain," he said.

The wells, which were drilled by Saga Petroleum U.S., Inc., are each expected to pro-

100th Anniversary of light bulb Edison Foundation launches observance

A year-long celebration commemorating the 100th anniversary of the invention of the incandescent electric light bulb by Thomas Alva Edison, is currently being conducted on an international basis, under the sponsorship of the Thomas Alva Edison Foundation.

GSU board chairman W. Donham Crawford is a trustee and vice chairman of the Foundation.

To direct and coordinate the worldwide activities, the Foundation appointed an "International Committee for the Centennial of Light." Its members include chief executive officers of corporations inspired by Edison's work. In addition to guiding the plans and administering the activities of the celebration, the ICCL is responsible for raising funds through voluntary contributions from private sources.

Edison perfected the electric light bulb on October 21, 1879, in his laboratory in Menlo Park, New Jersey. Of his 1,093 patents, including the phonograph and the motion picture camera, the incandescent lamp proved to be his best gift to mankind.

Paraphrasing an Edison biographer, Robert I. Smith, ICCL chairman, said "Although Edison

led no armies, conquered no countries, enslaved no people, his life and his inventions have influenced the course of history more than any other person in recorded civilization."

Edison himself once said, "If I have spurred men to great effort, if our work has widened the horizon of man's understanding even a little and given a measure of happiness in the world, I am content."

The "Centennial of Light" is also reviewing Edison's less famous achievements, from which much of today's technology has developed. Joining in the celebration will be a great many scientific and industrial organizations rooted in Edison's work.

The main objective of the centennial is to regenerate enthusiasm for invention and innovation.

Two utility executives join GSU as vice presidents

Fred C. Repper, vice president of public affairs for Central Power and Light Company of Corpus Christi for the past five years, was elected vice president of public affairs of Gulf States Utilities at a meeting of the board of directors in Beaumont September 26.

The appointment was effective October 1. Repper succeeds Jack Worthy, who returned to his former position as vice president of the Baton Rouge division.

A native of Fort Worth, Repper received his bachelor of science degree in agricultural engineering from Texas A&M University and his master of science degree in civil engineering from Colorado State University. He had been with CP&L for 26 years.

A registered professional engineer in Texas, Repper has served on a number of industry committees. He is currently chairman of the Geopressure-Geothermal sub-committee of the Geothermal Advisory Committee to the Department of Energy (DOE), and the sub-committee on commercial building for the Governor's Energy Advisory Committee on Energy Conservation. Repper also serves on the Advisory Committee on Geopressure-Geothermal to Center for Energy Studies, University of Texas and the Public Information Committee of the Edison Electric Institute (EEI).

As vice president of public affairs, Repper will be responsible for the company's governmental affairs, public and employee information and advertising.

Thomas H. Burbank, formerly senior vice president of finance at Edison Electric Institute (EEI), has been named GSU vice president of rates, economic analysis and strategic planning, effective September 1.

A native of Bridgeport, Conn., Burbank received

ed his bachelor of science degree in electrical engineering from Yale University in 1945. He joined EEI, the principal national association of the country's investor-owned electric utilities, in 1959.

Prior to joining EEI, Burbank was a rate consultant for EBASCO International. Before that, he worked in the rate department of the Connecticut Light and Power Company.

Active in a number of areas of the electric industry, Burbank has served on numerous industry-connected committees, including the following: Coordinating Subcommittee-National Petroleum Council's Committee on Energy Preparedness; Committee on Public Utilities-Business Advisory Council on Federal Reports, Office of Management and Budget; Project Committee of the National Electric Rate Design Study; and the Technical Advisory Committee on Finance, Federal Power Commission (FPC) National Power Survey.

Burbank is considered an expert in the field of economic forecasting and utility rate matters.

Leaders make 'contact' with benefits

How long has it been since you looked at that little green binder that has "Employee Handbook" and "Gulf States Utilities Company" on the front? At a recent CONTACT leader training session, 26 Gulf Staters not only looked at this book, but studied it thoroughly, in preparation for upcoming meetings covering employee benefits.

The place was the Sheraton-Chateau Charles in Lake Charles, Louisiana. For three days at the end of August, the 26 leaders for CONTACT, a program designed to disseminate information concerning subjects important to the utility business to GSU employees, went through extensive training on the topic "Employee Benefits."

Covering everything from retirement plans to medical insurance and financial aid to education, the leaders—representing all five of the Company's geographical divisions—had a full program, to say the least. Ken Huskey and Craig Armstrong, both of a California communications consultant firm, Ken Huskey and Associates, made the pace a fast, but complete, one.

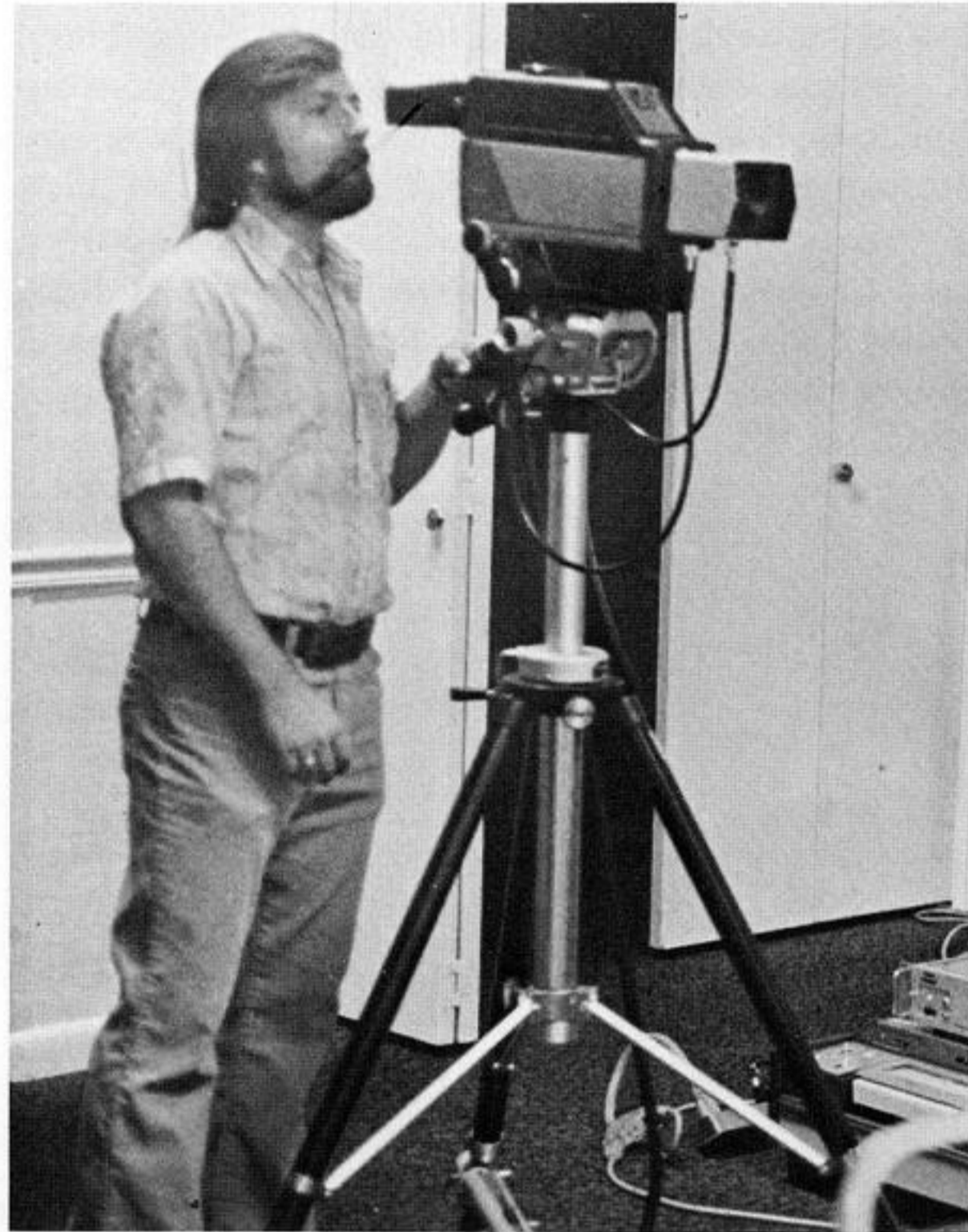
On Monday, the first day, the CONTACT leaders spent much of the time getting information from various representatives of Gulf States' Personnel-Employee Benefits section. The question-and-answer format was used as the leaders began getting the information they would need to conduct their meetings later.

The next two days, Tuesday and Wednesday, saw the Gulf Staters split into two smaller groups to practice their presentations on what they had learned and studied.

For help in evaluating their performances, the CONTACT leaders were put on camera, with a videotape system to record what happened. However, not everyone was overjoyed with this prospect. Said one leader, "I'm not going in front of a camera . . . I'll go home!" Every leader did eventually take his turn before the camera's eye, though.

After each leader made his presentation on the part of the employee benefits program he had boned up on earlier, he got to see himself on the videotape system's television screen. Then everyone evaluated the performance, commenting on everything from hand gestures and other body movements to speaking voice.

Yes, there were some sweaty palms and other signs of nervousness, but that was only natural. In general, the leaders agreed the methods used were very helpful. Even the "rookies"—new leaders who had not worked on the other CONTACT programs covering rates, nuclear power and alternative energy sources—did well their first time out.

The leaders put in three very busy days, but there was some relaxation to go with the work. The first night saw almost everyone have dinner at the motel, as Hurricane Debra came ashore between Lake Charles and Beaumont. The rain was hard and blown by a gusty wind, so no one was really anxious to venture very far.

Tuesday evening, after a full day of CONTACT work, the GSU folks wound up in a local seafood restaurant. There was plenty of lively talk in that dining room on that particular evening!

The training continued on Wednesday, with more leaders getting up before the cameras. Again, the nervousness was there, but the presentations were still good. For encouragement, each speaker got a round of applause when he was through.

After a wrap-up and summary of what had been covered, the leaders left, headed back to their various jobs in the Gulf States system.

Since then, the CONTACT leaders have been holding meetings on employee benefits, passing the word on. Of course, it all began in Lake Charles, when some GSU employees took a lot more than a casual look at that binder labeled "Employee Handbook."

duce an average of about 3.3 MMCF (million cubic feet) of natural gas and 60 barrels of condensate per day from the Mooringsport Limestone Formation at about 13,400 feet.

Marshall R. Young Oil Company is the major partner in the venture with a 50 percent interest. In addition to Varibus' interest of about 12 percent, Saga, the operator of the wells, owns nearly 20 percent and Public Service Company of Oklahoma has an investment identical to Varibus.

According to the terms of the agreement, Varibus has the right to add other wells to the contract. Two wells are being tested or are awaiting testing at 13,400 feet. An additional

well is drilling.

One of these, the Leo Seal Well No. 1 was drilled to 22,432 feet, found dry and plugged back. Further testing has shown the Mooringsport to be non-productive in that well. "Operations in that well have been temporarily suspended," said Hodges, adding that nine sections (nine square miles) in the vicinity of the well have been farmed out to others for further testing of the Mooringsport.

Varibus holds a minor interest in three other wells in the field, which have been completed by other producers. Saga is continuing further development of other wells with the participation of Varibus.

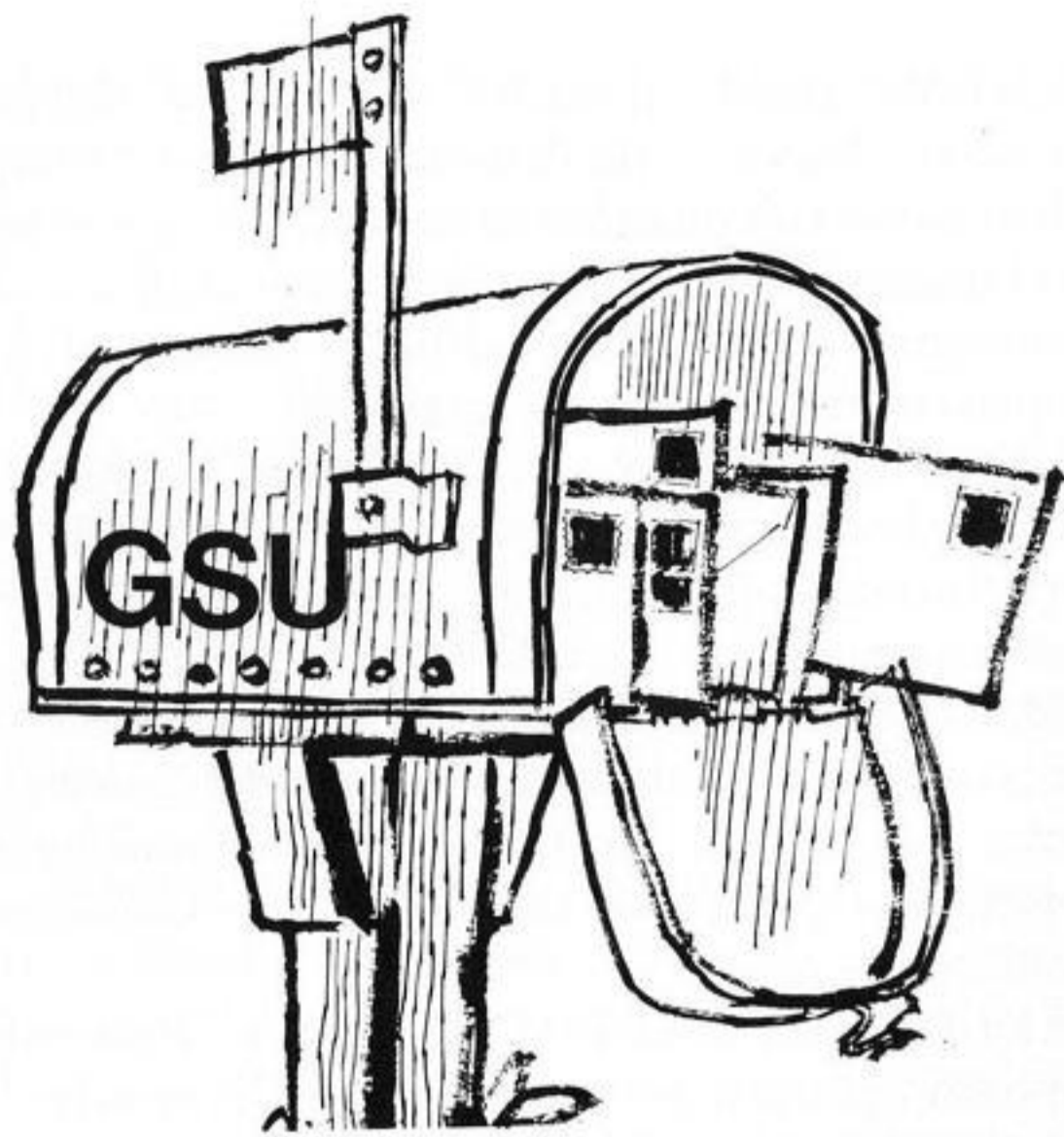

with arms, legs and a head. "Later we improved on it," he added.

"This lawyer thought we ought to copyright him but when we did we discovered that Reddy Kilowatt had been copyrighted 30 days before by a man named Ash Collins," (founder of Reddy Communications, Inc. owners of the trademark).

At any rate, Aleck was copyrighted and used extensively for several years. He was finally replaced in 1938 by Reddy Kilowatt, the nationally syndicated cartoon character used by many of the nation's investor-owned utilities.

But, whether it's Aleck Tricity or Reddy Kilowatt, Sutton believes that electric companies need to be personified in some way. "A large company like Gulf States just can't talk like the Reddy figure can."

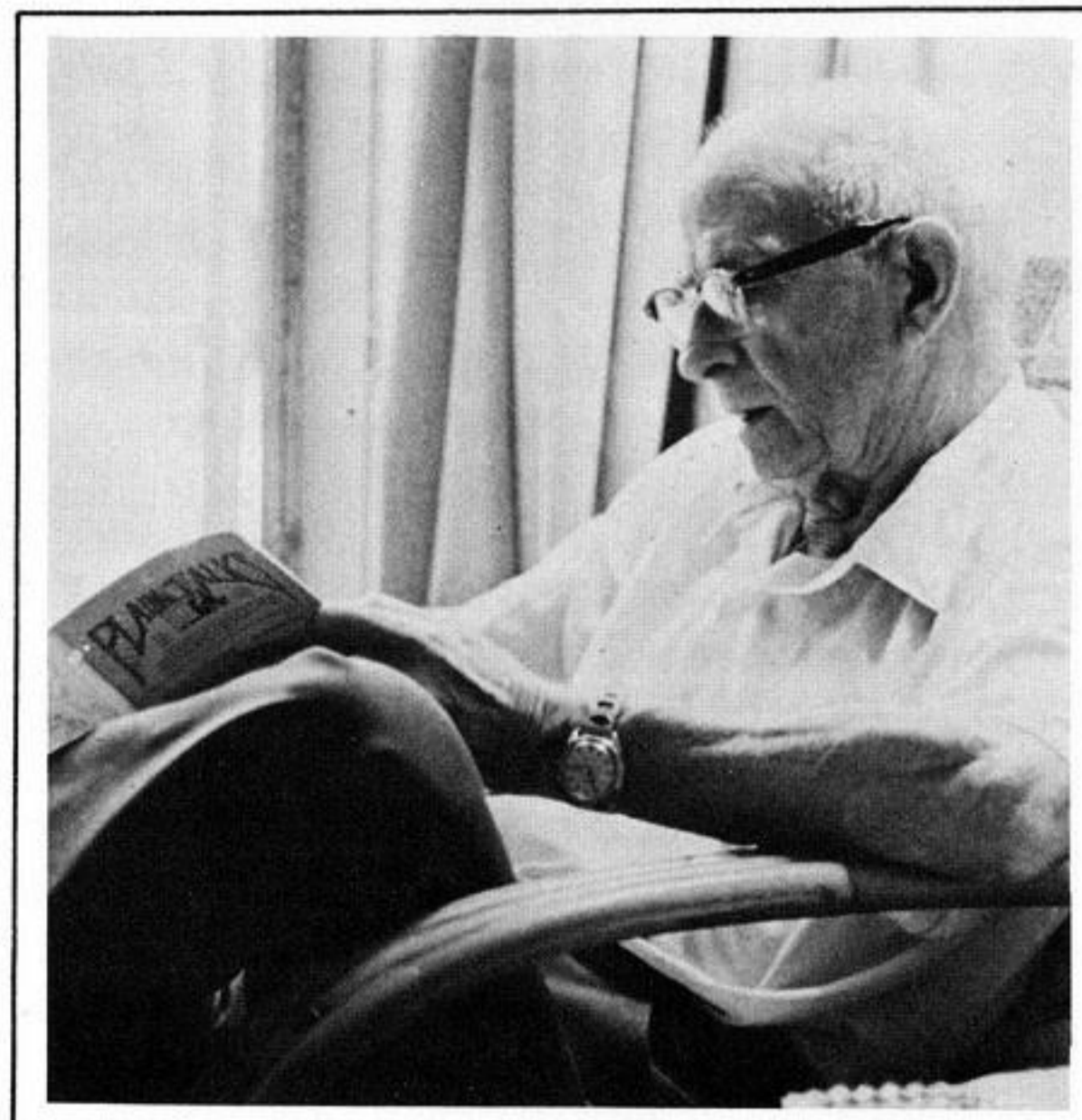
Actually, said Sutton, the company did very little formal advertising in the beginning. "About all the advertising we did in the early years was an 'institutional ad' in 'progress editions' that papers would sell the company once a year. This was more of a goodwill gesture than anything else."

Under Sutton's direction the Gulf States advertising department won local and national recognition during his nearly 40 years with the company. "We used to have a lot of fun with advertising," he reminisced.

"I recall the time we got the sheriff to come down with a chain and a padlock. We put a meal in the oven and got the sheriff to chain it shut for eight to ten hours. We showed him locking and unlocking the oven. When we opened the oven, here was this perfectly cooked meal."

It was Sutton who developed the slogan "an electric range cooks the food, not the cook."

And there were other innovations, all designed

to show the wonders and benefits of electricity.

Take, for example, the exhibit Sutton put together for the fair one year. "I'm sure it wasn't original. We had a 110-volt DC motor, which of course can act as a generator, rigged up with a bicycle. The generator was hooked up to a panel of lights and we invited people to see how much electricity they could generate. They were surprised to learn that they couldn't pedal hard enough to light a 25 watt bulb for more than a few minutes."

Sutton can't really remember having many real public relations problems during his GSU career. "Every employee was a good public relations man or woman and most of the time we were reducing rates while improving services.

"For awhile our record was downtrend, rates actually went down, so we had few problems with the public or regulatory agencies," recalled Sutton.

"The electric home was unheard of when I started with the company. Annual consumption was maybe 250 to 200 kilowatthours per home.

"In the early years, everyone had a lot of enthusiasm and was new on the job. It was sort of hip-hip hooray most of the era. We were growing," he said, looking back on years long since gone.

"It's still a growing concern. But it's a helluva lot bigger concern."

Deaths

Five retired GSU employees have died since the last notices were published in *PLAIN TALKS*.

Missing now among the retired are **Forest F. Elkins**, Crystal Beach, Tex.; **Ben Gray, Jr.** and **Clarence B. Barron**, both of Baton Rouge; and **Lonnie C. Pace** and **Harold J. Petetan**, Beaumont.

Elkins, who died on August 29, joined the company in 1934 as a bill deliverer in Port Arthur. The Army veteran has held a number of positions during his 41-year career with GSU, all of them in the Port Arthur division.

He was a senior consumer services representative at the time of his retirement in 1975.

Gray died on August 14, ten years after his retirement from the production department at Louisiana Station.

Born in Erwinville, La., Gray attended school in the Baton Rouge area. He was employed by GSU in 1928 in Beaumont and two years later he was transferred to Louisiana Station.

Gray served in the U.S. Army during World War II.

Barron died September 12 following a long illness. He was 74.

A native of Quincy, Mass., he was a graduate of the Massachusetts Institute of Technology with a degree in business and engineering administration. Barron joined GSU in 1928 and held a number of posts with the company, including Baton Rouge division sales superintendent from 1954 to 1963. He retired in 1965.

Barron was the first Gulf Stater called to active service during World War II. He attained the rank of colonel by the end of the war, a rank he held in the honorary retired reserves until his death.

He was preceded in death by his wife, the former Alice McMasters.

Pace, who died on September 9, retired in 1964 after 38 years with the company.

The Pine Hill, Tex., native was hired in 1926 as an electrician's helper in Port Arthur. After transfers to Beaumont and back to Port Arthur, Pace was moved to Beaumont for good in 1934 where he worked as an electrician at Neches Station. He served as electrical maintenance foreman from 1947 until his retirement.

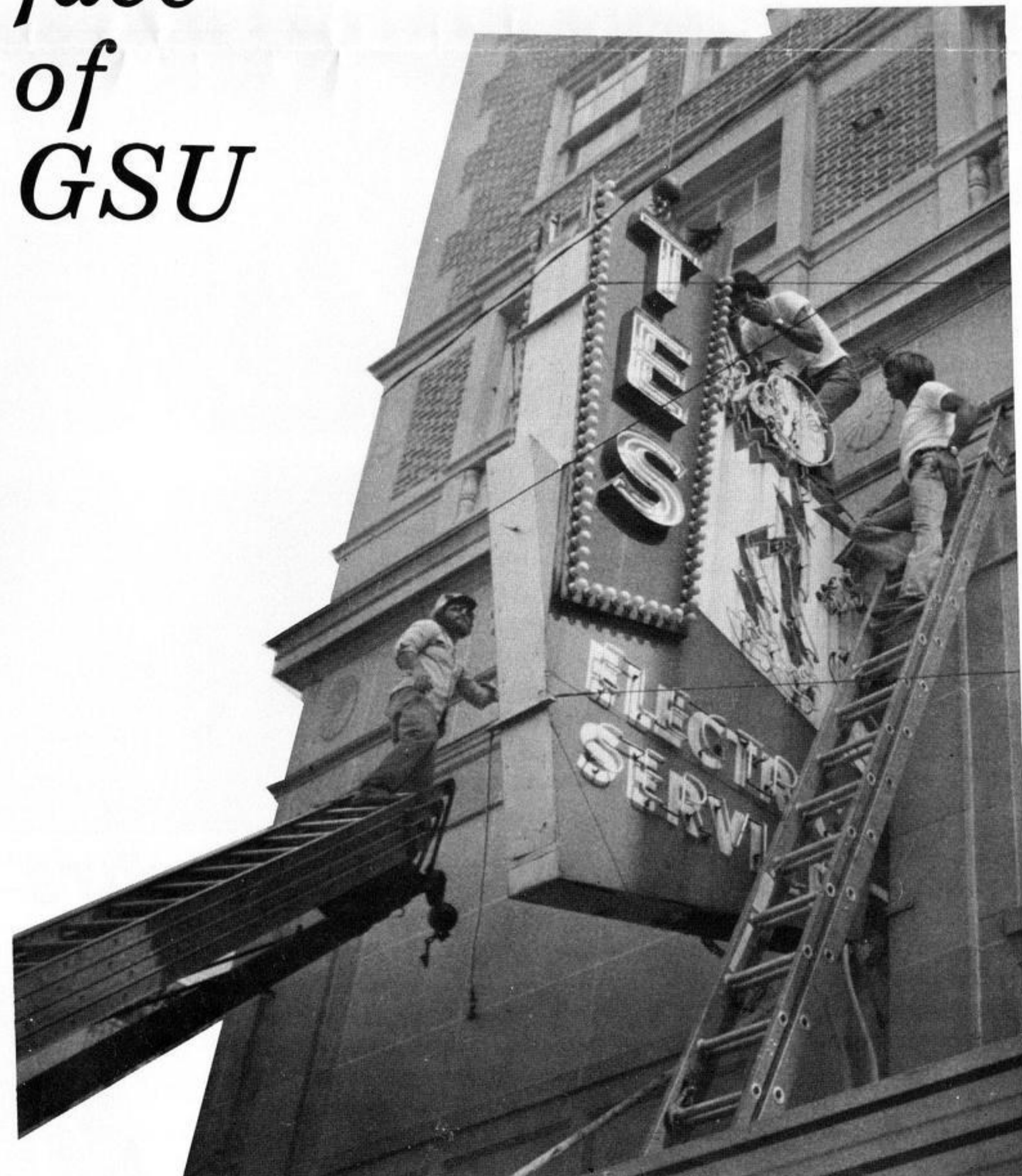

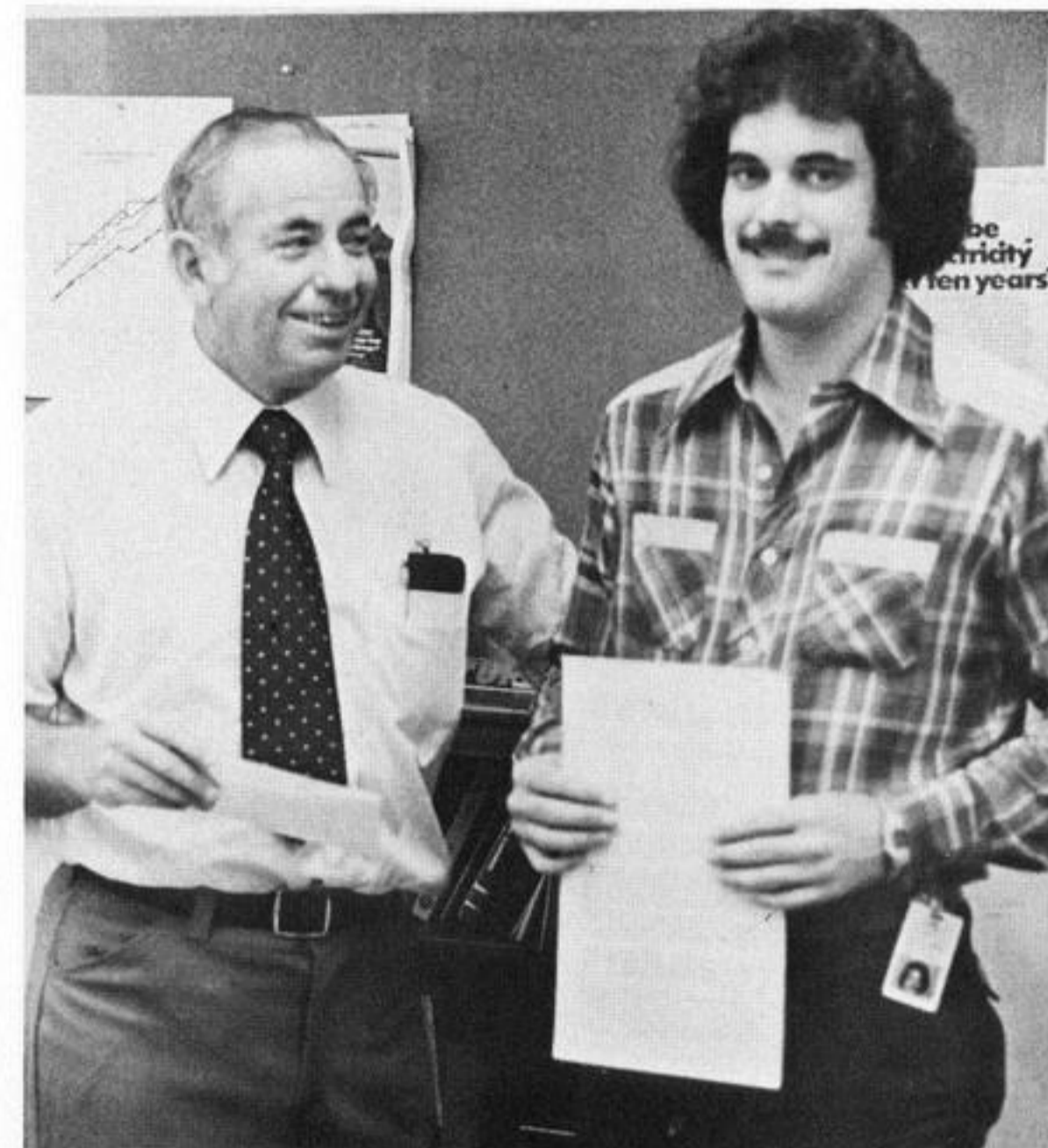
